

TERMS OF BUSINESS - WEDDING PHOTOGRAPHY

The terms of business and contract detailed herein pertain to provision of photographic services and should be read fully prior to signing of hard copy and subsequent engagement of our services. It is mutually agreed that no variation or modification to the terms shall be deemed valid unless agreed by both parties and confirmed in writing.

BOOKING: A deposit of £50 is required at the time of booking, along with your acceptance of terms by way of signed copy.

YOUR RIGHT TO CANCEL: A 7-day cooling-off period is effective from the signing of the contract, following which the deposit is non-refundable, the booking is confirmed and the contract is in force.

BALANCE OF PAYMENT: The balance becomes due immediately on delivery of package.

FEES: The fee covers supply of photographic services in accordance with the chosen option. Payment for any additional albums, digital media, reprints and/or enlargements becomes due in full at the time of delivery or at the point of ordering if carried out via the client login facility featured on the website.

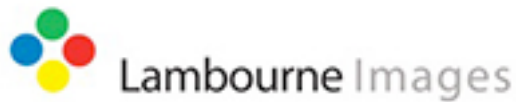
CREATIVE LICENCE: It is agreed that following joint consultation of the coverage, you grant us sole licence to best enable your requirements to be met without further redress to us. You should be aware that whilst we endeavour to accommodate all requests, we are unable to guarantee compliance due to circumstances beyond our control such as - but not restricted to - inclement weather, availability/willingness of any requested personnel, and/or any occurrence(s) which may adversely affect the portfolio.

VIEWING, COPYRIGHT & REPRODUCTION: Low resolution proof images are provided in electronic format. Limited reproduction rights may be purchased via one of the DVD options. The 1998 Copyright, Designs and Patents Act assigns copyright to the photographer unless purchased outright by the client for an additional fee.

You may not therefore copy or reproduce – nor allow to be copied or reproduced - any image(s) by any means whatsoever unless purchased via one of the DVD options. Unlimited reproduction rights are granted for either personal or non-profit use only, reproduction for either profit or commercial use is strictly prohibited under this agreement.

Additionally, as copyright owners, we reserve the right to reproduce any images taken for promotional/publicity purposes without recourse to the client.

EXCLUSIVITY AND PRODUCTIVITY: We aim to discharge our professional duties with maximum courtesy and minimum delay. You should therefore advise guests engaged in private photography/video coverage not to unduly hinder our work.



We reserve the right to respectfully request guests to refrain from taking private footage at any time should it be considered detrimental to our service.

FORCE MAJEURE: In the event of photographic failure, liability shall be limited to a maximum refund of monies paid to date, and it is agreed no further claim will be considered at any time. Similarly, should we need to cancel this contract for reasons beyond our control, (e.g. death, injury, sickness, conflict, natural disaster etc.), liability shall be limited to a refund of monies paid to date.

COMPENSATION: Following confirmation of contract, cancellation for whatever reason will be subject to a cancellation fee to compensate for loss of income.

Number of days before the wedding

- 30 days or less: 20%
- 31-90 days: 5%.

If the cancellation is deemed a postponement, then - subject to availability - monies paid to date may be credited against the new date. Total fees payable shall be those applicable at the time. In the event of unavailability for the revised date, a refund of monies paid to date, less the non-returnable deposit, shall be made.

QUERIES : Our aim is to respond to any query within 48 hours of receipt.

PRIVACY: No personal and/or contact details are divulged to a third party at any time without prior permission of the client.
