

# Short-Term Loan (STL) 2015/2016

#### **Short-Term Loans**

- Short-Term Loans (STLs) are available to full-time undergraduate, postgraduate and PGCE students who are waiting to receive student finance from their funding body
- An interest-free repayable loan of up to £400
- Students who wish to take out a STL must agree to repay the total amount taken as soon as the first instalment of their Student Loan/Grant, NHS bursary or guaranteed funds have been is received

## Who is eligible for a STL?

- Full-time undergraduate and PGCE students with "Home" status (not courses that are salaried)
- Students who are eligible, and have applied for, their maximum entitlement to student finance
- International students, who wish to be considered for a Short-term loan are required to seek advice from a Student Support and Wellbeing Adviser

#### Please note:

When applying for a STL, students **are required** to provide:

- their student ID card
- an up to date balance of their current account (i.e. a mini-statement)
- a print out from their funding body website showing the status of their student finance application

#### You must:

- answer all questions by printing clearly in black ink and by ticking the appropriate boxes
- provide a completed Confirmation of Attendance form signed by your Department
- submit PHOTOCOPIES of all relevant documents
- · be fully registered on your course
  - o all DBS and health checks must have been cleared
  - your ID and qualifications must have been checked

Please return the completed form to the Student Financial Support Administrators, Student Support, Health and Wellbeing, CCCU, North Holmes Road, Canterbury, Kent CT1 1QU.

Once your loan application has been authorised, you will receive an email from the Student Financial Support Administrators confirming:

- the amount of loan
- the payment date
- the date the loan is to be repaid

#### Repayment of Short-Term Loan

The Student Support and Wellbeing Advisers will ask you to sign a formal agreement confirming the terms of the loan and making it clear that a formal process will ensue should you fail to meet these.
