1. TIME ELEMENT

The burglary occurred on 04/06/2014 at 0236 hours. It happened when the suspect Dorial Green-Beckham unlawfully entered the residence and assaulted the victim Taylor Drayton.

2. M.O.

The apartment front door faces west into the parking lot. Entry was made through the unlocked front door. The door was forced open by Green-Beckham when the resident Jordan Scott was attempting to close the door in an attempt to keep Green-Beckham out of the house. While Green-Beckham was in the house he assaulted the resident Drayton by pushing her down at least 4 stairs onto the floor.

I took photos of the point of entry, the damage to the wall made by the door and of the victim. No DNA and no finger prints were taken due to the fact the victim knew the suspect and could easily identify him.

4. STOLEN PROPERTY

There was no stolen property.

5. SUSPECT INFORMATION

The suspect is Dorial Green-Beckham. He is an associate of the victim Taylor and she stated he was the person who unlawfully entered her residence and assaulted her.

6. WITNESS INFORMATION

Jordan Scott a roommate of the victim heard a knock at her front door. She stated she was expecting guests and opened the door. She stated when she opened the door she realized it was not the guests she was waiting for, it was Dorial Green-Beckham. She stated she attempted to shut the door and Green-Beckham pushed the door open forcing his way into the residence. She stated he pushed the door with so much force that it made the door knob go through the drywall of the wall next to the door. She then stated Green-Beckham went into the house and was looking for Samantha Bass. She stated her roommate Taylor Drayton was on the stairs and she observed Green-Beckham push her in the chest with two hands making her fall down at least 4 stairs. She stated Green-Beckham and Bass then left the residence.

Samantha Bass is Green-Beckham's girlfriend and friends with Scott and Drayton who were in the residence. Bass stated "I was in the bathroom, I didn't hear or see anything." Bass was extremely uncooperative.

7. GENERAL INFORMATION

On 04/06/2014 at 0236 hours Dorial Green-Beckham unlawfully entered 310 Old Plank Rd W apt . Jordan Scott opened the front door thinking her guests had arrived and noticed it was Green-Beckham and tried to shut the door. Green-Beckham then pushed the door open forcing his way into the apartment. When Green-Beckham pushed the door open it caused the door knob to go through the drywall of the adjacent wall. Green-Beckham went further into the residence trying to locate Samantha Bass. Green-Beckham descended a flight of stairs and Taylor Drayton on the stair case. Green-Beckham pushed her with 2 hands causing her to fall down at least 4 stairs striking the floor. Green-Beckham then left with Bass.

The victim Drayton had slight bruising and swelling of her right wrist and had limited movement of her fingers on her right hand. She did not want medical attention at the time and stated she would go to The urgent care center the following day to get her wrist looked at.

I have applied for a warrant for Green-Beckham's arrest for the charge of 1st degree burglary.

On 04/06/2014 at 1927 hours Drayton and Scott came down to the Columbia Police Dept and stated they wished to speak with me about the case. Drayton stated she had been talking to Bass via text all day and she no longer wanted to press charges against Green-Beckham for the burglary. I asked Drayton why she no longer wanted to go ahead with prosecution and she stated she was afraid of the media and community backlash since Green-Beckham is a football player for the University Of Missouri and is possibly going to be in the NFL draft soon.

Drayton stated she was afraid of being harassed and having her property damaged just because she was the victim. Drayton stated she did not want to deal with the mental stress of the whole ordeal it was already making her physically sick to think about it.

I then asked Scott if she was wanting to still press charges and Scott informed me that she also no longer wanted to press charges. I asked her why she did not want to continue with prosecution and she stated she did not want to put her friend Drayton through the mental stress of it, as well as being afraid of retaliation against her and her property.

I had Drayton and Scott fill out decline of prosecution forms which I have placed into evidence.

I asked Drayton I could see the text messages between here and Bass to which she replied yes. The text messages are as follows

Bass: " I want to talk to you about what's going to happen. I know you're so upset and I am too. Dorial was wrong in every way and you have every right to be furious. I'm not sticking up for him but football really is all he has going for him and pressing charges would ruin it for him completely. I agree that something should be done- whether that's paying for what he did with money or a different way. I really just want all of us to move past this and not have this happen again by completely being done with him. I can't do this anymore. Now he's hurting my friends not just me. I really am so sorry you're in this position and I never meant for this to happen."

Bass: "I love you!"

Drayton: "And the problem is he didn't mind throwing that down the drain lastnight"

Bass: " I know, Taylor. It wasn't right at all. No part of me wants to be with him and last night made me realize so much. I'm not sticking up for him, but it's the rest of his life. he deserves to pay somehow but without football he really does have nothing. He wouldn't have nothing. He wouldn't make it in a real job. He'd be n the streets and in prison like his brothers. I understand how upset you are. I am too- he drug me out by my kneck and hurt me too. Him hurting my friends hurts me more than you know and like I said it made me realize so much. I really am done. Just please think about it before you do anything I'm begging you."

Bass: "Reports are already being let out. This is going to be a huge deal if you press charges. It'll be over for him. Please Taylor"

Drayton: "I have no control over what is out That's not in my hands"

Bass: "Do you know what's going on or you're going to do?"

Bass: " Is your hand okay? Are you okay? Mom said she can help you fix your wall herself. She's done it plenty of times"

Bass: "I don't think Dorial should be let off at all bc he needs to be shown that he can't just do whatever he wants bc of who he is. Have you thought about making him do classes, or counseling, and pay your hospital bill?"

Bass: " Can you call me? Or the police department? And not have him arrested"

Drayton: " Him being arrested isnt my doing. That's Anyone that has a reports made on them. My mom will talk to him at some point"

Bass: "John wants your moms number please. It's serious and I'm sorry I don't mean to upset you i jus want to be done with this and let him go. I don't want to deal with this either."

Drayton: " she's at a basketball game and is not in town and said she's not having me go down there or make any decisions without her there so there's nothing I can do"

Drayton: "She can talk in 30 minutes over the phone"

Bass: "Okay. The best thing would be is for us all to go together or you call when your mom and you talk. And if you didn't want to press charges just say we

all had a alot to drink and what not everything is fine. It jus needs to be quickly. Dorial doesn't have a phone or he would be talkjg to you not me"

Drayton: " There's a police report made on it and that would be lying, so basically everything on paper is made up is what I would be saying"

Bass: " It's in your hands tho. You can do and say whatever you want about this. We just need to move quickly on this before he's arrested and before his warrant is made public. He will be kicked out of Mizzou and the not qualify for the draft next year. The coaches talked to me and explained to e how serious this is and there's no time to waste at this point"

Bass: "Can you please call them? Please Taylor. Ask what you can do"

Drayton: "My mom said they can call her in 10 minutes"

Bass: " All his dad is asking is to let the police know that you aren't pressing charges. That's all he needs before this investigation happens."

Bass: "We're running out of time"

Bass: "And he'll pay you for all the damages done. Guaranteed"

Bass: " If you aren't pressing charges it needs to be done by 6, Taylor. Please do something quickly it's going to be a distaster, I know you're upset but this is a huge deal. Please work with him and his family."

Based on the fact that the victims in this case have declined prosecution I have requested the warrant for Green-Beckham to be withdrawn.

On 04/07/14 approximately 5:05 PM I made public service contact with Samantha BASS. Ms. BASS had allegedly been the victim of a domestic assault involving a boyfriend identified as Dorial GREEN-BECKHAM. During initial investigation of a first degree burglary by officers who responded to the address belonging to a Taylor DRAYTON, and a Jordan SCOTT, information was gathered that the suspect, GREEN-BECKHAM, had entered into the residence and contacted Ms. BASS, and left with Ms. BASS.

Original officers had taken a burglary report and assault report from Ms. DRAYTON in reference this incident. The apartment was being leased by Ms. DRAYTON and Ms. SCOTT. Ms. DRAYTON alleged she received injuries, and had been pushed when Dorial GREEN-BECKHAM had entered her apartment seeking Ms. BASS. Later in the evening, Ms. DRAYTON had contacted the original officer and requested to not have charges brought against Dorial GREEN-BECKHAM and apparently signed a decline to prosecute form due to perceived pressure she may receive by pursuing charges against Mr. GREEN-BECKHAM. During the course of the original officer's investigation, and questioning Ms. DRAYTON about why she was now not wanting charges brought, she stated she received texts from Ms. BASS requesting her not to pursue charges. The original officer requested to read those texts which Ms. DRAYTON allowed him to read and document.

Due to the fact I am a domestic violence investigator, I was asked to contact Ms. BASS to inquire with her about what may have happened in DRAYTON'S apartment and after she (Bass) left the apartment. Officers were led to believe that GREEN-BECKHAM and BASS were in a romantic relationship. I wanted to ask BASS if she was assaulted by GREEN-BECKHAM as she said she was in her text(s) to DRAYTON. I also wanted to see if she had any concerns or questions about what was alleged in the original report. Also, due to the text she sent Ms. DRAYTON, there were questions as to what might have happened to her, and allegations of a possible domestic violence case.

I contacted Ms. BASS on her cellphone, and introduced myself and why I was contacting her. First, I asked Ms. BASS if she was alright, and if she had any injuries she wanted to report to me. She stated she was fine, she had no injuries, and was not concerned for her safety. I asked Bass about what had occurred at her friends, Taylor DRAYTON'S apartment. BASS informed me that Mr. GREEN-BECKHAM had arrived at the apartment, and she had walked out with him, and they left. I asked her about the accusation she may have been assaulted while in a bedroom of that apartment by GREEN-BECKHAM. BASS stated again, that she had walked out of the apartment with him.

I inquired with Ms. BASS if she had texted Ms. DRAYTON after the incident at DRAYTON'S apartment. BASS informed me that she had indeed sent several text to DRAYTON asking her not to pursue charges against GREEN-BECKHAM. I then read Ms. BASS a portion of the text messages that she sent to Mr. DRAYTON, specifically the specific text was where she was asking Ms. DRAYTON not to pursue charges a small sampling of those text(s) follows. BASS is stating to Ms. DRAYTON in her text(s) "I understand how upset you are. I am too - he drug me out by my neck and hurt me too. Him hurting my friends hurts me more than you know and like I said it made me realize so much. I really am done. Just please think about it before you do anything. I'm begging you." I asked Ms. BASS if she had sent these texts to Ms. DRAYTON. Bass stated she did text

that. I asked her specifically about the sentence where she said she was grabbed by the neck, and he drug her out by the neck and hurt her. She stated she did not remember texting that. She stated she had been drinking. She stated she did not remember texting that specifically to Ms. DRAYTON. I then asked her if what she said in the text was accurate. She said she did not remember. She again stated all she did was when Mr.. GREEN-BECKHAM arrived, she walked out with him.

I then asked Ms. BASS if she had been contacted by coaches, and had pressure put on her not to cooperate with the charges being brought against GREEN-BECKHAM. Ms. BASS said she did not receive any calls from the coaching staff. I then asked her about a text she sent. Ms. DRAYTON where she states in the text "He will be kicked out of Mizzou and not qualify for the draft next year. The coaches talked to me and explained to me how serious this is and there's no time to waste at this point." Ms. BASS told me the coaching staff did not talk to her, that they had talked to Mr. GREEN-BECKHAM, and he had relayed that information to her. I questioned her on the specifics of her text, again where she said coaches talked to her. She would not admit to that happening other than saying she did send the text, but repeated the coaches talked to Mr. GREEN-BECKHAM and he asked her to relay that information.

Ms. BASS then asked if she could talk to me at a later time. I stated she could. I had the feeling at that time she probably would not recontact me, but either a parent or some other person might contact me in the future. I told Ms. BASS I was not here to specifically have charges brought against Mr. GREEN-BECKHAM, but rather to provide services as she needed. She stated she appreciated that, but would talk to me at a later time. I then gave her my cell phone number.

At approximately 5:30 PM on 04/07/14 I was contacted by a person who identified herself as Samantha BASS' mother. This person called me while I was driving and I could not get their first name. She did tell me on two occasions, however, I did not have the ability to note her first name, and forgot what that was. This person, who I will call Mrs. BASS, explained to me who she was, asked that I not contact her daughter any further, and that her daughter did not want to talk to me any further. I advised Mrs. BASS that her daughter was an adult, and could make that decision herself and if I needed to talk to her further during my investigation, I would do so. Mrs. BASS informed me she had been living with this kind of stuff most of her life, and she believed that her daughter being an adult, she could make her choice as to whether she wanted to live the same kind of life she did, or not. I asked Mrs. BASS if she knew what had occurred to her daughter that night. Mrs. BASS stated she did know, that her daughter even tells her when she goes to the bathroom. I explained to Mrs. BASS what my job was, and that I had experience with domestic violence cases, and my goal was to help her daughter, not arrest Mr. Dorial GREEN-BECKHAM.

On 04/08/14 I contacted Alexander GASKILL. Mr. GASKILL was a caller to the Public Safety Joint Communications on 04/06/14 reference an incident located at 310 Old Plank Road in the area of apartment .. Mr. GASKILL called in a disturbance and in the notes of the 911 call stated that a male was "manhandling a woman".

After identifying myself to Mr. GASKILL, I asked what he remembered seeing on 04/06/14 in the early morning hours. Mr. GASKILL states he arrived home around 2 or 3 in the morning; that he had been at the bars, and drinking. He stated he could hear a bunch of screaming. Mr. GASKILL stated he overheard a female yelling that she had a hole in her wall, and she had been pushed down some stairs. Mr. GASKILL stated his apartment building is what he would describe as at least a football field away from the incident that occurred. Mr. GASKILL stated he started walking towards the area of the disturbance, and he talked to some people gathered there who he thought were neighbors of the female in question. He stated he observed 3 men sitting in a car. He described the vehicle as being white or silver in color. He stated that vehicle left, and then came back. He stated the males were 3 or 4 African American males. One of them had a female by the arm walking her down the sidewalk and then the car left. Mr. GASKILL stated he was asked by other people who were at the scene when the incident occurred to contact law enforcement. He said he did call 911.

Mr. GASKILL stated he could not identify the male who had ahold of the female, and barely could identify the female as a white female wearing what he believed to be white clothing. He stated the male wore a flat brimmed hat, and maybe a "wife-beater" tank top, but he was not certain. Mr. GASKILL stated he could not identify any of the parties involved, and was not close enough to be able to really discern any particular action that was taking place. Mr. GASKILL stated law enforcement arrived shortly after he called 911.

Mr. GASKILL had nothing further to add to this statement, other than if he remembered anything further he would contact me.

On 04/08/14 at approximately 11:25 AM I made contact with a Chris CONNOR. Mr. CONNOR lives near the residence of this burglary incident on Old Plank Rd at the Brookside Apartment complex. I was able to gather Mr. CONNOR'S name from an article in the Columbia Missourian newspaper published on 04/08/14 where he is quoted as saying, "After Green-Beckham drove away his teammates were yelling at us not to call the cops Connor said. They were like 'dude come on, just don't call the cops.'" I believed Mr. CONNOR may be a potential witness to what occurred outside of the apartment after the alleged burglary occurred. I believed he may be a witness of a domestic assault crime between Dorial GREEN-BECKHAM, and a Samantha BASS.

Upon contacting Mr. CONNOR I asked him to tell me what had occurred. He stated he was inside his house, heard noises, went outside and saw a group of people yelling and screaming, and saw a white car leave the area. Mr. CONNOR advised that other people were telling him that DGB (otherwise known as Dorial GREEN-BECKHAM) was involved, however, he never did see Mr. GREEN-BECKHAM. I then read to him his statements as reported by the newspaper which he advised me he did not state that he saw anything. He had actually called the journalist who wrote the article, and told her that he was misquoted, and he was told they would try to change the quote in the paper before it went to press, however, that did not occur.

I asked Mr. CONNOR what he saw. CONNOR stated he witnessed these people arguing and yelling, and the car leave. He stated he did not recognize anybody or see anybody do anything wrong. He stated he did see a girl walk up to the car, and then walk back into her apartment, but he did not see anything else. Mr. CONNOR stated he did overhear 2 or 3 black males talking to other people at the scene, and he did hear one of them state they were a teammate of Mr. GREEN-BECKHAM, and that male was saying please don't call the police, just chill out, we know what he did was wrong, but he does not need to get in trouble.

Mr. CONNOR said he did not call 911, because it appeared other people were calling 911. Mr. CONNOR stated one of the people at the scene he knew, and he was pretty certain they had witnessed what had occurred outside the apartment, however, he was not certain that person would want to speak with me. I gave Mr. CONNOR my information, and asked him to forward that information to this person. Mr. CONNOR later emailed me saying he had given the witness my information, and they would call me if they desired to do so.

I have nothing further to add to this investigation at this time.
