**Retained Fee**

**Payments**

Payments can be picked up in the store during normal store hours (cash paid up to \$50).

Payments over \$50 will be paid out by check or via paypal upon request (\$1 mailing fee).

Payments & store credit not picked up/requested 6 Months after consignment end date will be voided.

**Liability**

Items remain the property of the consignors and are not covered under the insurance policy of Cuddle Bugs.

All prices are determined by Cuddle Bugs. Items may be reduced or removed from the floor at any time.

**Unsold Items**

Unsold merchandise must be picked up by the end of the month listed on this contract (\$5 yearly storage fee applies). Items not picked up become property of the store and may be sold or donated.

Items consigned MAY NOT be picked up before the consignment end month.

24 hours' notice is required if you want us to pull your items for you. Otherwise you will be responsible for finding your items yourself. We are not responsible for lost items.
