METHODS OF PAYMENT

We accept Bank Drafts, Money Orders and Personal checks for the total amount of your order. Please do not send cash. Charge cards: Visa, Discover, MasterCard and American Express accepted.

METHODS OF SHIPMENT

USPS: Most orders are sent via USPS, heavy packages are sent via Fed Ex. Small packages are generally shipped via USPS.

Note: FedEx will not deliver to PO Boxes

Priority Mail: For deliveries to AK and HI

Air Mail/Air Parcel Post: For deliveries to Canada and foreign countries

Orders to foreign countries – MasterCard, Discover and Visa only. Subject to local regulations. Appropriate shipping charges will be added to order.

DAMAGED OR MISSING CLAIMS
