Dear Ms. Kessler:

This letter is written to serve as official acknowledgement and acceptance of your letter of resignation on behalf of the Los Angeles Recording School, dated August 30, 2011, effective the close of business this date, August 31, 2011. It is noted for the record that, on August 23, 2011, LARS submitted a teach-out plan/agreement, along with subsequent requested documentation received August 24 and 26, 2011, that the institution successfully completed the teach-out/transfer of the three remaining enrolled students, prior to the institution's planned consolidation with the LA Film School. As requested, the institution included evidence of the teach-out or transfer of each of these students, with signed attestations from each that the teach-out/transfer was conducted in a manner acceptable to the student. Upon review of this documentation, ACCET approved, on August 29, 2011, the teach-out plan/agreement and its subsequent implementation, as represented in the submissions by the Los Angeles Recording School. Having satisfied this condition and based upon the receipt of the referenced letter of resignation of accreditation, the institution is no longer subject to the Commission's action letter, dated April 29, 2011.

Since the accredited status previously held with ACCET is now withdrawn, the institution must take timely steps to return the previously issued certificates of accreditation to ACCET, **no later than September 15, 2011**, and to ensure that any website references, brochures, catalogs, advertisements, letterhead or other documentation used by the institution, which makes reference to ACCET and/or the institution's prior accredited status with this agency are expeditiously corrected, removed from circulation, or destroyed.

In closing, we extend our best wishes to you, your staff, and students in their respective endeavors.
