

**ADDENDUM # 2 TO VEHICLE LEASE AGREEMENT
BETWEEN BARD OF SUMTER COUNTY COMMISSIONERS
AND RIDE RIGHT, LLC**

WHEREAS, on July 26, 2011, Ride Right, LLC (OPERATOR) and Sumter County Board of County Commissioners, a subdivision of the State of Florida (COUNTY), entered into a Contract (the "Contract"), in which the OPERATOR was the successful bidder for Request for Proposal # 006-0-2011/AT to provide for and in behalf of the COUNTY transportation services.

WHEREAS, on September 13, 2011, Addendum # 1 was entered as part of the original Agreement relative to making vehicles available to the OPERATOR in advance of full implementation of the Contract to facilitate training of new OPERATOR staff.

WHEREAS, in association with the Contract, the parties entered into a Vehicle Lease Agreement which they wish to amend to more accurately memorialize the intention of the parties with regard to the provisions of the Agreement pursuant to Exhibit IV, item 13, of the original Agreement relative to the OPERATOR's requirement to carry at all times, Insurance on all the vehicles year round.

THEREFORE, the parties hereto, being fully advised of the terms herein, and having been advised by legal counsel, do hereby agree to amend the Exhibit IV, Vehicle Lease Agreement of the Contract by this writing (the "Addendum") and state the following:

1. That the "WHEREAS" recitals above are hereby acknowledged as true and accurate and are incorporated as if stated herein.
2. This addendum will change item 13 from "as stated herein" to: The OPERATOR shall, at all times, carry General Liability, Auto Physical Damage (as specified by County per vehicle), Auto Liability and Worker's Compensation Insurance pursuant to the insurance requirement in RFP # 006-0-2011/AT, naming Board as an additional insured in each such policy and also provide an Endorsement for Waiver of Subrogation on General Liability and Auto Liability. OPERATOR will be responsible for payment of all deductibles. The OPERATOR will be required to carry insurance coverage on the two International School Buses for 10 months during the Sumter County, FL, public school year, (August – May) effective June 1, 2012.
3. Any provisions of the original Agreement not replaced or contradicted by this Amendment remains in full force and effect. In the event of any conflict between the terms of this Addendum and the original Agreement, the terms of the original agreement shall prevail.
