If the client cancels the performance they must do so in written notification to the musician within 14 days prior to the event.

All cancellations will incur a \$100 fee and the remainder will be refunded to the client.

If the Musician cancels the performance, they must do so in written notification to the client within 14 days prior to the event and refund all monies paid by the client.

In the event of an emergency or if the musician cancels within Seven days prior to the event. The musician must arrange alternative performers at no extra cost to the client. If this is not possible, all monies received will be returned to the client.

If the performance area is outdoors, the client agrees to provide protection from sun, wind and rain for the musician/s.

Client will also ensure the musicians have access to a safe stage area with direct electrical supply and must have enough safe space for:

2 x P.A Speaker Sound System on Stands, Lighting Set, Drum/percussion Set, Guitar Set, Microphone Boom/Stand. A stage area of minimum 3m x4m is recommended.
