- ♦ Please send the filled form along with a clear scanned copy of your passport to the Reservations Department on to our fax +974-44460401.
- ♦ Kindly note that your passport should be valid for at least 6 months from the traveling date
- ♦ It is mandatory to fill up all fields of the form for Visa processing purposes.
- ♦ A Visa processing fee (Application fee selected on the first page) applies per person for processing the Visitor's Visa. This charge will show in your hotel folio once you check in to the St. Regis Doha. Due to government law the application fee is 100% non-refundable and therefore the charge will be applied to your credit card regardless of the reservation status.
- ♦ Additionally, a deposit of the first night stay will be charged to your credit card which will be credited to the guest bill upon check-in.
- ♦ All visa documents need to be submitted to the Hotel within the delay stated above (21 days for standard visa, 15 days for urgent visa).
- ♦ The guest must have a Credit Card with minimum credit limit of QR 5000 or cash equivalent as per requirement of the immigration authorities. The hotel will hold a pre-authorization of that amount per person until leaving the country. Failure to comply with the above may result in denied entry to Qatar.
- ♦ The Visitor Visa Application is subject to approval by the local authorities. The St. Regis Doha cannot guarantee that the Visa will be granted and consequently, cannot be held liable in the event that a visa will be denied or delayed. Visa processing is entirely at the discretion of the Qatari Government.
- ♦ Please understand that the Qatar Entry Visa is valid for one entry only. The St. Regis Doha does not process multiple entry visas.
