

**Agreement for Loan of Surplus Police Car by the City of Oxford
to the Town of Rosedale**

This Agreement between the Town of Rosedale, Mississippi (Rosedale) and the City of Oxford, Mississippi (Oxford) is entered effective the date the respective parties adopt minutes reflecting such Agreement.

WHEREAS Oxford owns a police car, VIN2FAFP71W34X134144 Ford Crown Vic 2004; and

WHEREAS Oxford has purchased a replacement police car for the above vehicle; and

WHEREAS Oxford is willing to lend the police car to Rosedale, upon such terms as may be acceptable to Oxford and Rosedale and as are permissible under Mississippi law; and

WHEREAS Rosedale has a public need for the police car; and

WHEREAS the police car shall be used only for the benefit of the public and on public property;

NOW, THEREFORE, Oxford and Rosedale agree as follows:

Pursuant to Mississippi Code Annotated Section 17-5-15, Oxford shall lend, and Rosedale shall borrow the police car, to be used by Rosedale only for public purposes and on public property. Rosedale shall continue to borrow such car until such time as Oxford requests its return, if that occurs. At such time, Rosedale shall return the police car to Oxford in the condition of the car at the time the request for return is made. Rosedale shall bear all costs and expenses related to this transaction, the use of the police car, and the return of the police car to Oxford, should that occur.

The parties specifically acknowledge that Oxford makes no representation regarding the safety, or condition of the police car for any purpose, and both parties agree that Rosedale shall determine, using appropriate professional means, whether the police car is safe and suitable for the public purpose to which Rosedale may choose to use the police car.

The Parties' respective governing bodies having approved this Agreement on the terms stated herein, the Agreement is executed by the Mayor of Oxford and the Mayor of Rosedale, as shown by their signatures below:

This Agreement between the Town of Pace, Mississippi (Pace) and the City of Oxford, Mississippi (Oxford) is entered effective the date the respective parties adopt minutes reflecting such Agreement.

WHEREAS Oxford owns a police car, VIN 2FAFP7aW45X125924 Ford Crown Vic 2005; and

WHEREAS Oxford has purchased a replacement police car for the above vehicle; and

WHEREAS Oxford is willing to lend the police car to Pace, upon such terms as may be acceptable to Oxford and Pace and as are permissible under Mississippi law; and

WHEREAS Pace has a public need for the police car; and

WHEREAS the police car shall be used only for the benefit of the public and on public property;

NOW, THEREFORE, Oxford and Pace agree as follows:

Pursuant to Mississippi Code Annotated Section 17-5-15, Oxford shall lend, and Pace shall borrow the police car, to be used by Pace only for public purposes and on public property. Pace shall continue to borrow such car until such time as Oxford requests it's return, if that occurs. At such time, Pace shall return the police car to Oxford in the condition of the car at the time the request for return is made. Pace shall bear all costs and expenses related to this transaction, the use of the police car, and the return of the police car to Oxford, should that occur.

The parties specifically acknowledge that Oxford makes no representation regarding the safety, or condition of the police car for any purpose, and both parties agree that Pace shall determine, using appropriate professional means, whether the police car is safe and suitable for the public purpose to which Pace may choose to use the police car.
