CLUB HOURS

- The timings of the Club will be:-
- Summer (April to September) - 6 AM to 11 PM
- Winter (October to March) - 7 AM to 11 PM
- On Friday, Saturday & Sunday both in winter and summer the Club hours will be up to 12 mid-night only for Restaurant.

GRATUITIES/TIPS TO CLUB EMPLOYEES

No member, visitor, dependent or guest shall give any money, fee or gratuity to any employee of the Club nor shall the latter receive the same on any pretence whatsoever. Infringement will invoke disciplinary action, which may extend to dismissal of Membership.

CONDUCT OF CLUB EMPLOYEES

The conduct of a Club employee shall in no instance be made a matter of personal reprimand/action by any member. All complaints regarding the behavior and conduct of Club employee shall be made in writing to the Head of the Club who shall enquire into the circumstances of the case and take action as may be considered necessary and advise the member concerned. Complaint/Suggestion Books are provided at various locations at Reception, Members may register their complaints/suggestions in the Complaint Books.

ADMITTANCE

- A photo ID and a valid GOLD Club membership card is required for entry into a GOLD Club.
- Individuals must be at least 18 years of age for Club membership or access without a responsible, supervising adult for person below 18 is restricted.
- Members must be 21 years of age to access Club with a self-service bar, unless accompanied by a responsible, supervising adult who is also a Club member.
- Apollo DB city issued security gate pass is not valid for Club access.
- GOLD Club reserves the right to refuse admittance to anyone who interferes with the business-like atmosphere of the GOLD Club.
- Attire while in a GOLD Club must be in keeping with good taste and a dignified atmosphere.
- GOLD Club reserves the right to terminate any membership or remove any member or visitor for inappropriate conduct, including but not limited to, conduct that's undignified, disruptive, abusive or violent, or for failing to comply with membership terms and conditions.

FEES

- In addition to the joining and renewal fees, GOLD Club reserves the right to charge a fees for any service requested by a Member, including the issue of a replacement Card.
- GOLD Club may amend the fees at any time. Current fees are listed on the GOLD Club rate card and are available from the GOLD Club Front Desk.
- GOLD Club will waive the replacement Card fees under any of the following circumstances:
 - (a) the Card has been stolen and application form has been submitted to GOLD Club; or
 - (b) the Card was not received by the Member from GOLD and the Member provides a Statutory Declaration verifying the non-receipt within two months after payment of the joining fee or requesting a replacement Card.

FOOD & BEVERAGES

- Alcoholic beverages will not be served to anyone less than 21 years of age, subject to license of such services.
- Food and alcoholic beverages from outside are strictly prohibited in Gold Club Premises

GUESTS

- A member may bring immediate family or guests into the GOLD Club, provided that GOLD Club determines that adequate space exists. However, you must remain with your guests at all times during the visit.
- Guest and family privileges apply only when the visitors accompany the member.
- Guests and family members must abide by GOLD Club Rules.
- Guest will be charged as per club policy.
- Family of an Individual club member will also be charged if they use any paid facility other than café and restaurant.

MEMBERSHIP

- GOLD club memberships are non-transferable and non-refundable.
- Membership is effective from the date of purchase and continues for the duration of the membership type purchased.
- For memberships that are renewed prior to the expiration date of a current membership, the length of the membership purchased will be added to the current expiration date.
- Members must agree to abide by and be subject to all the GOLD Club Rules.
- Membership will be terminated for inappropriate conduct or for not adhering to the Club Rules.
- The membership card is the property of GOLD Club and must be returned upon request.
- GOLD Club Rules must be observed or membership may be terminated without compensation.
- GOLD Club members will not be compensated for changes in locations, rates or Club Rules.

SMOKING

Smoking, chewing tobacco, smokeless tobacco and electronic cigarette use is not permitted in any area in GOLD club.

CLUB PROPERTY

• REMOVAL OR DAMAGE TO THE CLUB PROPERTY

No member, dependent, visitor or guest shall injure, mutilate, or take away from the Club for any reason whatsoever, any newspaper, book or any other article, crockery or any other item, being the property of the Club. Any member or visitor injuring, breaking or otherwise damaging or removing the property of the Club, shall at the discretion of the Committee be called upon to make good such damage or loss and to pay such further amount by way of fine as the Committee may decide. A member shall be liable for any breakages, loss or damage caused by guests or visitors introduced by him/her.

• LIABILITY OF THE CLUB

All members, visitor dependants and guests who enter upon the club premises or in any other area or consume any form of food, refreshments or water supplied by the Club, or park their vehicles on or in the vicinity of the Club premises, or leave any article(s) of whatsoever nature in or on the club premises, whether in lockers or elsewhere or in deposit with any office bearer or staff of the club, do so at their own risk and cost and the club shall not be liable under any circumstances for personal injury sustained by them or loss or damage to their property notwithstanding that such injury, loss or damage may directly or indirectly be due to, occasioned by or contributed to by the negligence of the Club or any of its office bearers committee members, staff, members of their servants or any person whatsoever. No member & their Guest of the club shall under any circumstances claim damages of any kind from the Club for any reason whatsoever, nor shall he proceed legally or otherwise against the Club for the realization of any claim whatsoever and the decision of the Committee shall in all such matters be final.

GOOD BEHAVIOR

All members are expected to conduct themselves with utmost restraint and gentleman / lady like behavior: Any Member resorting to foul language or physical violence within the Club premises is liable for Disciplinary action.

NOTICES

All notices will be posted in the Club premises in such part thereof and in such manner as the Committee may from time to time determine. No Notice of any kind shall be placed in the Club premises except by the authority of the Committee or the Secretary and in a pre designated area.

PET POLICY

Pets are not permitted in the GOLD club include dogs, cats, and household birds or any other pet animal.
