Recruitment will be made for the above vacancy and also for the vacancies reported for Special Recruitment from Scheduled Tribes only during the pendency of the list.

5. Method of Appointment : Direct Recruitment (Special Recruitment from among Scheduled Tribes only).

Note:- Applications received from candidates other than Scheduled Tribe candidates will be rejected. Individual communications regarding the rejection of their applications for the above reason will not be issued.

6. Age : 18 – 40; Only candidates born between 02.01.1972 and 01.01.1994 (both dates included) are eligible to apply for this post. (No other age relaxation will be allowed).

Note:- In the absence of qualified candidates within the age limit the upper age limit shall be relaxed up to 50 years. But in no case the maximum age limit shall exceed 50 (Fifty) years.

7. Qualifications :-

1) SSLC or equivalent.

2) (a) Diploma in Electrical Engineering after three years course of Study issued by Government of Kerala or Qualification equivalent there to.

OR

(b) KGCE in Electrical Engineering with one year experience as Second Grade Overseer (Electrical)

OR

(c) National Trade Certificate in the Trade of Electrician OR wireman OR Lineman with one year experience as IInd Grade overseer (Electrical).

OR

(d) Diploma in Electronics and Communication.

OR

(e) KGTE/MGTE Group Certificate in Electrical Engineering in Four subjects viz. Electric light and power (Higher) Applied Mechanics (Lower) Heat Engines (Lower) and Machine Drawing (Lower) with 2 years experience as Second Grade Overseer (Electrical).

Note :- The experience as IInd Grade Overseer must be from KSEB/Govt. Service/Govt. owned undertakings.

8. Method of Submitting Application :-

Candidates shall register as per 'ONE TIME REGISTRATION ' system on the Official Website of Kerala Public Service Commission 'www.keralapsc.org' for applying for the post. Candidates who have registered shall apply by logging in to their profile using their User- ID and password. Candidates shall click on the 'Apply Now' button of the respective posts in the Notification link for applying for a post. No application fee is required. Candidates can view and have a print-out of the details in the profile by clicking the link Registration Card, if required. Candidates are responsible for the correctness of the personal information and secrecy of password. Before applying for a post, candidates must ensure correctness of the information in their profile. They must quote the User- ID for further communication with the Commission. Applications once submitted will be received as provisional and particulars shall not be deleted or altered after submission. Applications submitted not in accordance with the conditions of the notification will be summarily rejected. Documents to prove Qualification, experience , community, age etc. have to be produced as and when called for .
