### 1. Overview

- 1.1 The Trading Operations Report provides information on the state of the BSC market; including issues and incidents and a summary of the key events that may have had an impact on BSC Parties. The Trading Operations Report is produced each month and is based on data for the reporting month.
- 1.2 The report contains nine sections, which each appear on their own webpage, so the report can be personalised to the interests of the customer. Digital graphs are provided, that in some cases can be filtered to drill down into the data. Elxon also provide commentary and backing data for each graph.

### 2. Changes to the Trading Operations Report.

- 2.1 In autumn 2020, the Analysis and Insights team reviewed the reports we provide to industry. These reports included the [Trading Operations Report](#), [BSC Operations Headline Report](#), [Peer Comparison](#), [System Price Analysis Report](#) and the [Smart MTD Report](#). We reviewed these reports to ensure they were accessible, customer friendly, digital and overall provide value to the end user.
- 2.2 Previously, the Trading Operation Report was one pdf document with 37 pages containing all of our trading operations reporting. We have since made the following changes:
  - We have split the sections of the report into nine webpages to make it easier for customers to find the reporting that is relevant to them;
  - We have moved the graphs to a Power BI format, which allows the end user to filter and drill down into the data;
  - We saw this as an opportunity to consolidate some of our analysis and reduce double reporting and as such, moved the System Prices section from the Trading Operations Report to the System Prices Analysis Report. This is so that it can sit with our other System Prices analysis; and
  - We have improved our Peer Comparison Graphs by publishing interactive Power BI graphs (previously these graphs were only available in a pdf format).
- 2.3 We are continuously looking at ways we could improve our external reporting and provide insightful analysis and insights for end users. All the Trading Operation Report pages now have an embedded survey to gather feedback that will help us to develop the report.
