



### **Tour Confirmation Agreement**

This **Tour Confirmation Agreement** (this "**Agreement**") is between **Junior Bus Tours, Inc. ("Junior Tours")** and **Athens High School** (the "**Group**"). Junior Tours and the Group agree that:

#### **TOUR PACKAGE**

Junior Tours will provide the Group a tour of **Orlando** from **February 7-10, 2014**, with the following:

- \* 3 night's accommodations (Disney Property)
- \* 3 breakfasts
- \* 3 dinners
- \* Round-trip air transportation
- \* Motorcoach for airport transfers
- \* Sightseeing tour as per itinerary (1 YES program)
- \* Free chaperones in the ratio of 1 to 20 paying in double occupancy
- \* \$500 cash stipend
- \* Promotional materials, accounting and rooming list forms, and baggage tags
- \* All admissions and taxes while on tour
- \* Insurance- Junior Tours, Inc. maintains professional liability insurance policy

#### **NUMBER OF PARTICIPANTS TOUR FARE AND PAYMENT PROCEDURE**

The all inclusive price on quad occupancy is **\$1169\*** per person. The Tour price is based on **20+** paying participants. Should the final number of paying participants fall below 20/30/40 paying participants, Junior Tours reserves the right to increase the tour fare and/or adjust the Tour Package accordingly.

The total tour fare shall be paid according to the following deposit schedule (Should the Group require additional time to make these payments, please call Junior Tours):

<b>1st Deposit</b>	<b>\$200 per person</b>	<b>Due 10/11/2013</b>
<b>2nd Deposit</b>	<b>\$400 per person</b>	<b>Due 11/19/2013</b>
<b>Balance</b>	<b>\$569 per person</b>	<b>Due 1/3/2014</b>

**\*If the group size is 30+- the price will be adjusted to \$1069 per person**

**\*If the group size is 40+- the price will be adjusted to \$1019 per person**

#### **ROOMING LIST - ADDITIONAL ROOMING CHARGES / AIRLINE FEES**

The Rooming List should be forwarded to Junior Tours as soon as it becomes final, but not later than six weeks prior to the departure date.

Tour package price includes double rooms for complimentary chaperones. Any other person opting for (i) single occupancy will pay \$100 per person per night; (ii) double occupancy will pay \$50 per person per night; and (iii) triple occupancy will pay \$25 per person per night.

Any tour participant that deviates from the group air flights shall pay a fee of \$200, plus any difference in airfare determined by the airline. Any tour participant that changes a name on an airline ticket after the ticket has been issued shall pay a fee of \$200 per name change. In addition, any fees for checked baggage (where applicable) are not included in the Tour Package and must be paid directly to the airlines upon check in.



## **GENERAL RESPONSIBILITIES AND POLICIES**

### **ALL PAYMENTS ARE NON-REFUNDABLE.**

Junior Bus Tours, Inc., its employees, shareholders, directors, agents, (collectively "Junior Tours"), does not own, operate or control any person or entity which provides goods or services for your Tour including , for example, lodging facilities, transportation companies, guides, entertainment or sightseeing operators, restaurants, etc. All such persons and entities are independent contractors. As a result, Junior Tours is not liable for any negligent or willful act on such person or entity, or of any third party.

The Tour price is based upon an agreed to minimum number of full paying travelers and specific activities as set forth on the sample itinerary. Failure to reach the minimum number of paying participants and/or the addition of new activities to the Tour may necessitate an increase to final Tour Price. Junior Tours reserves the right to pass along to the Group any and all unforeseen increase in supplier cost (e.g. fuel surcharges, taxes or fees) imposed by airlines, motorcoach companies and other common carriers and/or vendors. In addition, fees for checked baggage are not included in the Tour Package and must be paid directly to the airlines upon check in.

Changes in hotels or itinerary may be made at the discretion of Junior Tours if deemed necessary or desirable. Junior Tours reserves the right to cancel any Tour with its sole obligation to refund all monies received by it for the Tour. Junior Tours is not responsible for any lost or stolen items while on Tour.

Without limitation, Junior Tours is not responsible for any injury, loss or damage to person or property, death, delay or inconvenience in connection with the provision of any goods or services whether occasioned by or resulting from, but not limited to, acts of force majeure, war, civil unrest, insurrection, strikes or other labor activities, criminal or terrorist activities of any kind, lost or stolen belongings, overbooking or downgrading of accommodations, mechanical or other failure of airplanes or other means of transportation or for any failure of transportation mechanism to arrive or depart timely, dangers associated with animals, sanitation problems, food poisoning, lack of quality of medical care, illness or disease, difficulty in evacuation in case of medical or other emergency, or for any other cause beyond the direct control of Junior Tours or your Group Leader.

Junior Tours specifically disclaims any and all responsibility for the general supervision and behavior of tour participants. The number of complimentary chaperones provided by Junior Tours is not a recommendation as to the actual number of chaperones that should accompany the Tour. The actual number of chaperones accompanying the tour shall be determined by the Group in its reasonable discretion. Junior Tours reserves the right to decline to accept or retain any person as a member of any trip. Junior Tours reserves the right to cancel any Tour with its sole obligation to refund all monies received by it for the Tour.

Any controversy or claim arising out of or relating in any way to this Tour Confirmation Agreement or any other information relating to in any way to our Tour, or the Tour itself, shall be settled solely and exclusively by binding arbitration in Newark, New Jersey in accordance with the rules of the American Arbitration Association then existent.
