The cancellation deadline for this conference is June 28, 2013. Cancellation before this deadline will result in a *refund of the registration fee*.

Cancellation after June 28, 2013, will result in a *forfeiture of the registration fee*. Contact Coaches Outreach ASAP if you need to cancel (others cannot cancel for you). In most cases, we have a waiting list for each conference and can easily fill your spot with a couple from the waiting list.

If you cancel *after* the deadline and no one fills your spot, you *will incur a \$250 cancellation fee* (in addition to the registration fee forfeiture). You are welcome to help us find another couple to fill your spot.
