Once an item(s) have been deemed unsalable the owner will be notified and asked to either pickup, greatly discount, or donate the item(s).

As a general rule, unsold items left at Dunn's Attic & Auction House are donated to various local charities, such as Family Renew, Habitat for Humanity, Domestic Abuse Council, Hospice, and Halifax Humane Society.

Additional Terms and Information:

- 1) Dunn's Attic & Auction House is acting as the seller's agent
- 2) Consignments are left at the owner's risk. Insurance is held by Dunn's Attic & Auction House and all reasonable security precautions will be taken. However, the store is open to the public, and Dunn's Attic & Auction House cannot be held responsible for items broken, lost to theft, damaged by fire, smoke, or water.
- 3) Dunn's Attic & Auction House uses proprietary software for our consignors to monitor their sales. The cost of accessing this tool is \$1.00 a month, and will be automatically deducted from each account.
- 4) My signature acknowledges and certifies that I am the lawful owner, that I have the lawful right to sell, and that there are no claims, liens, or encumbrances on any item that I have put up for consignment.
- 5) 50 % of the sale price for each of my items sold will be held in my account and paid to me by check.
- 6) It is the sole responsibility of each consignor to pick up their consignment check. (Unless other arrangements have been made) The checks are available for pickup the first business day following the 15th of each month after your item(s) have sold.
- 7) This Agreement shall be governed by the Laws of the State of Florida.
- 8) I have read the above agreement and accept all of its terms.
