

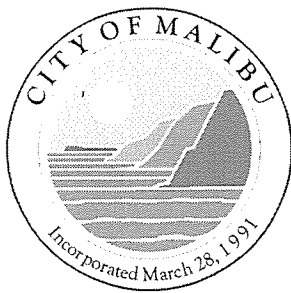

CALL TO ORDER

Chair Frost called the meeting to order at 5:06 p.m.

ROLL CALL

The following persons were recorded in attendance by the Recording Secretary:

PLEDGE OF ALLEGIANCE

Commissioner Roberts led the Pledge of Allegiance.

APPROVAL OF AGENDA

MOTION Chair Frost moved and Vice Chair Wright seconded a motion to approve the agenda with Item No. 4.B. to be heard prior to Item No. 4.A. The motion carried unanimously.

REPORT ON POSTING OF AGENDA

Senior Administrative Assistant Ayala reported that the agenda for the meeting was properly posted on February 27, 2019.

ITEM 1.A. PUBLIC COMMENTS

None.

ITEM 1.B. COMMISSIONER COMMENTS

Commissioner Laetz expressed concern about a prescribed burn planned by the Los Angeles County Fire Department. He stated it should be discussed with the public in advance. He suggested the City discuss with the Fire Department the status of and its philosophy regarding fire breaks.

Vice Chair Wright discussed repainting of a curb near the Malibu Pier.

Commissioner Cohen discussed the City's rejuvenation of the Dolphin Sticker program. He stated the Sheriff's Department was considering the expansion of the Malibu Volunteers on Patrol (VOP) program.

Commissioner Roberts stated he had never heard of a prescribed burn in the Malibu area before. In response to Commissioner Laetz, he stated fire breaks are extremely helpful.

Chair Frost stated a previous control burn took place in Malibu Canyon in Calabasas about six or seven years ago and it got away from them. He stated most fire breaks have been allowed to become overgrown. He stated State Parks stopped fire breaks from being maintained to protect Monte Nido. He discussed increased truck traffic on Pacific Coast Highway (PCH). He stated he spoke to California Highway Patrol (CHP) about implement ways to stop trucks from coming down Kanan Dume Road. He stated the new VOP car had been delivered. Public Works Superintendent Aladjajian confirmed the car would be put into service once the insurance was activated. He commended Public Works staff for their tireless work. He confirmed Dolphin Stickers were available from the receptionist at City Hall.

In response to Commissioner Roberts, Chair Frost stated vehicles must be registered in Malibu to purchase a Dolphin Sticker.

In response to Commissioner Roberts, Lieutenant Seetoo explained how the Dolphin Sticker program worked. She stated they would not permit residents in during a mandatory evacuation, but it would allow residents into Malibu through a soft closure. She stated it was added to the Lost Hills Station operation plans and would be included in staff briefings before deployment.

Chair Frost acknowledged Carol Randall and thanked her for her service to the Public Safety Commission. He commended her dedication to improving safety in Malibu.

Commissioner Laetz requested the Fire Department be invited to the next Public Safety Commission meeting to provide a fire update.

ITEM 3 OLD BUSINESS

None.

Commissioner Laetz stated the Commission needed to adopt a policy for setting the agendas for future meetings. He stated he was disappointed with this meeting's agenda.

Public Works Director DuBoux explained the Council assignment process for determining Commissions' tasks for the year and how the agenda was prepared each month.

Chair Frost stated Commissioners could discuss suggested items with their appointing Councilmembers.

Commissioner Cohen suggested Chair Frost take the list of priorities suggested by the Commission to the City Manager to have those priorities added to the agendas.

Vice Chair Wright agreed with Commissioner Laetz that something related to the Woolsey Fire should be on every agenda. She stated she reached out to members of the community concerned about the homeless issue and asked them to attend tonight's meeting.

Senior Administrative Assistant Ayala stated the Commission would review its assignments in April or May and make its recommendations to the City Council for assignment in the next fiscal year.

Commissioner Laetz requested the review of the assignments be included in the April 3, 2019 meeting agenda.

ITEM 4 NEW BUSINESS

B. Update on Projects Affecting Traffic on Pacific Coast Highway (PCH) and City Streets and February 2019 Storm Response

Recommended Action: 1) Receive and file status updates on projects affecting traffic on PCH and city streets, including: a) PCH at La Costa Pedestrian Improvements Project; b) Slope Stabilization Project (Caltrans); c) Fiscal Year 2017-18 Street Maintenance Project; d) PCH Median Improvement Project (Caltrans); and e) Caltrans maintenance work; 2) Receive and file update on the

City's activity in response to February 2019 storm events; and 3) Provide feedback or questions for Caltrans staff.

Public Works Superintendent Aladjadjian presented the report. He stated the La Costa crosswalk project construction would take approximately one month once it gets started. He stated Caltrans was focused on storm response and hired a private contractor to clear culverts and underpasses and keep roadways clear.

Public Works Director DuBoux stated he, the City Manager and Assistant City Manager met with Caltrans directors yesterday and toured the Malibu coastline to point out areas of concern. He stated the City would post changeable messaging signs (CMS) advising motorists to be aware of additional truck traffic in the City related to the CalRecycle debris removal process. He stated some trucks had to use Kanan Dume Road to access homes off that road.

Chair Frost stated two signs at Mulholland Highway advised truck drivers that they cannot use Kanan Dume Road.

Commissioner Laetz stated there had been about 17 signs along Kanan Dume Road in the County area stating that trucks were prohibited, but most of those burned and had not been replaced. He requested staff inquire about when Tunnel 3 would be fully reopened as it does not appear to be damaged. He expressed concern about debris in Trancas Creek causing the creek to meander and increasing the possibility of flooding on the highway. Public Works Director DuBoux stated Caltrans was considering an emergency project to shore the piers under the Trancas Bridge.

Public Works Superintendent Aladjadjian discussed City Public Works crews' and contractors' efforts before, during and after recent storm events. He thanked the VOPs for their assistance during the storms.

Commissioner Laetz stated members of the community were unhappy about the traffic signal at Civic Center Way and Webb Way. He stated residents thought the lights were too bright and questioned why a roundabout was not installed.

Public Works Director DuBoux discussed development projects in the area that required changes to mitigate future traffic impacts. He stated the signal was approved with the approval of the La Paz, Whole Foods and Santa Monica College projects and the developers paid for the improvements. He stated the City's traffic consultant reviewed the plans to ensure current standards were met. He explained traffic signals were exempt from the City's Dark Sky Ordinance. He stated there was not enough room for a roundabout at the time the plan was prepared.

In response to Commissioner Laetz, Public Works Director DuBoux stated the light plan was reviewed by the City's traffic consultant and met all current standards.



A. Services for Homeless Individuals with Mental Illness

Recommended Action: Receive and file report and presentation on services and strategies that are currently being used to address homeless individuals in Malibu who exhibit aggressive behavior and severe mental illness.

Public Safety Manager Dueñas discussed concerns expressed by members of the public at the February 6, 2019 Public Safety Commission meeting regarding increased problems with homeless individuals with possible mental illness confronting members of the public in parks and at the library.

Lieutenant Seetoo introduced Lieutenant John Gannon and Brandon Barkley of the Los Angeles County Sheriff's Department's Mental Evaluation Team (MET).

Lieutenant Gannon provided a presentation explaining MET's history, training, work, and deployment protocols. He stated a new MET office was projected for the Lost Hills Station by mid-2019. He stated response times for this area had come down from an average of 55 minutes to approximately 23 minutes. He stated 51 patients met criteria for involuntary hospitalization in 2018. He explained that MET response resulted in a significant reduction in use of force calls.

Chair Frost introduced Alex Gittinger from The People Concern to discuss current interactions with the homeless population in the City. Mr. Gittinger introduced Devan Liddle and Sabrina Petty, The People Concern's outreach team working with the homeless population in Malibu.

In response to Commissioner Cohen, Lieutenant Gannon explained the goal of MET was to remove homeless persons from the streets and place them in appropriate housing.

In response to Commissioner Cohen, Public Safety Manager Duenas stated the City had an agreement with The People Concern. She explained The People Concern worked with the homeless population in Malibu with compassion while being mindful of public safety.

In response to Commissioner Roberts, Mr. Gittinger stated he had seen a seasonal increase in the homeless population. Public Safety Manager Duenas stated meals for the homeless population were organized through various churches.

In response to Commissioner Laetz, Public Safety Manager Duenas confirmed the Malibu Community Assistance and Resource Team (CART) had organized meals in the past.

Mr. Gittinger explained The People Concern used opportunities to connect with as many homeless individuals as possible for case management and worked toward the goal of those individuals receiving more permanent services.

In response to Commissioner Laetz, Dr. Ryan explained homeless individuals could apply for a voucher to use public transit at no cost to access medical and mental health services.

In response to Chair Frost, Mr. Barkley explained how the Sheriff's Department, The People Concern, and the MET Team worked together to assist the homeless population.

C. Public Safety Agency Activity

Recommended Action: Discuss recent Public Safety Agency activities and receive and file monthly activity reports from the County of Los Angeles Sheriff's Department, Fire Department and Lifeguards.

Lieutenant Seetoo announced Coffee with a Cop scheduled for Tuesday, March 12.

Chair Frost announced Lieutenant Seetoo was awarded Woman of the Year by Senator Henry Stern.

Lieutenant Seetoo stated Malibu Tow had met the requirements to operate in the City and would be reinstated.

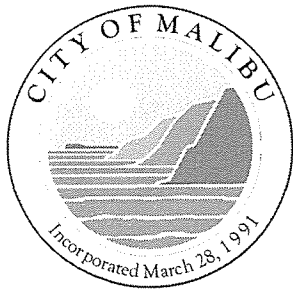

---

**RECOMMENDED ACTION:** Receive and file a report and presentation on plans for an upcoming "Whole Community" Public Safety Initiative, geared toward reducing residential and automotive burglaries during Summer 2019.

**DISCUSSION:** Each summer, visitors and residents converge on Malibu's beaches, shopping centers, and parks. Simultaneously, the number of reported automotive burglaries increases, especially along Pacific Coast Highway. These burglaries fall under two main classifications: "smash and grab" burglaries where the suspect gains vehicle entry by breaking a window, and unforced key entry burglaries where the suspect uses a key left by the victim in a wheel well or elsewhere. Thefts from unlocked vehicles, as well as residential burglaries, also increase during the summer months.

City staff, in collaboration with Los Angeles County Sheriff's Department (LASD) personnel, are proposing a community-wide approach to reduce the number of automotive and residential burglaries in Malibu. The Whole Community Public Safety Initiative aims to increase public awareness of crime prevention strategies across all sectors, reduce burglaries and other crimes of opportunity, and engage the community as an active player in public safety efforts.

To achieve these goals, the Initiative comprises three action areas that combine crime deterrence and community engagement. The first is a series of workshops led by LASD

with support from Malibu City staff. The workshops will take place in various locations across Malibu and will be geared toward residents as well as those who work in the City. Direct engagement with those who frequent Malibu's roadways, whether they are postal workers, delivery drivers, dog walkers, Neighborhood Watch members, business patrons, or others, will increase community capacity to identify public safety vulnerabilities sooner and more regularly. Because of the intent to increase community engagement across all sectors, these workshops will be held both during the day and in the evening to increase equitable access.

The second action area is an intensive social media campaign to be run jointly by the City's Media Information and Public Safety staff. Twice weekly social media posts on crime prevention best practices and reminding people to exercise situational awareness will run across all platforms, including Twitter, Facebook, and Nextdoor.

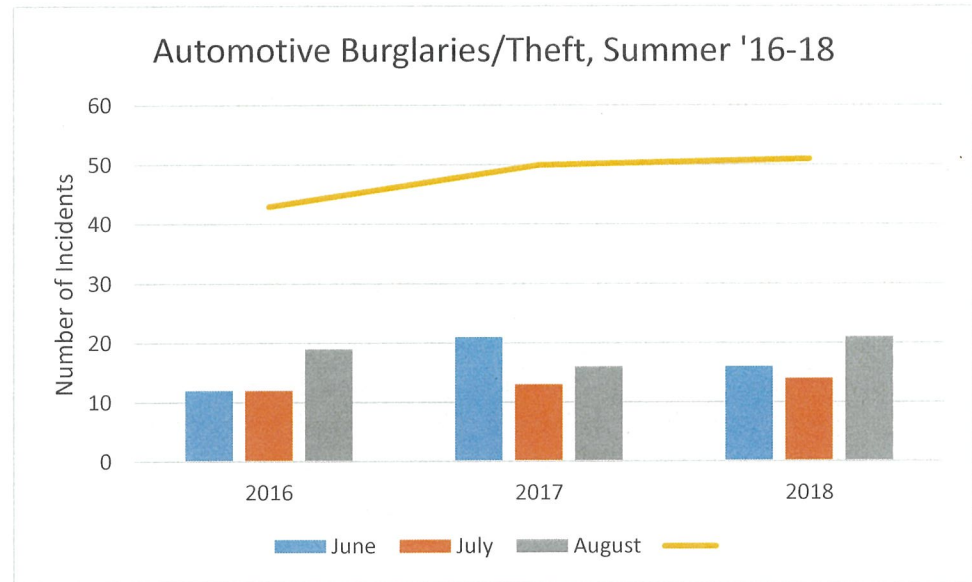
The third action area is signage to be displayed at specific burglary hotspots identified by LASD. Signage will serve as a reminder for residents and visitors to remove all visible property from and lock their vehicles when going to the beach, shopping, or dining. The signs are also intended to have a deterrence effect by giving law enforcement a presence even when deputies are not on scene. The signage will reinforce the messaging provided in both the workshops and the social media campaign.

Between Summer 2016 and Summer 2018, the number of reported automotive burglaries increased by 18.6%, while the number of residential burglaries increased by about 50% during the same period. The goal of this initiative is to reverse this trend and reduce the incidence of these crimes to below the 2016 crime rates. Staff will evaluate program effectiveness based on these metrics at the end of the summer.

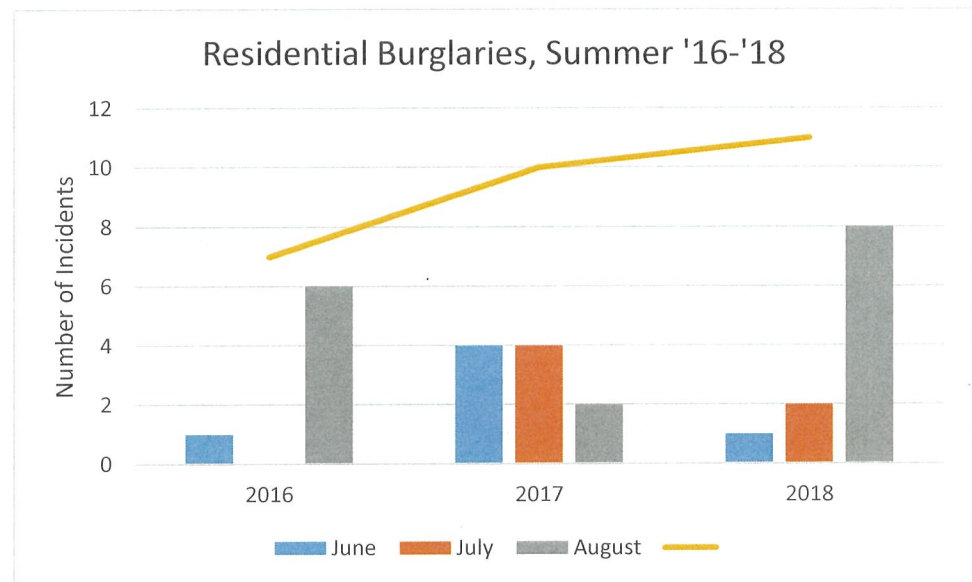

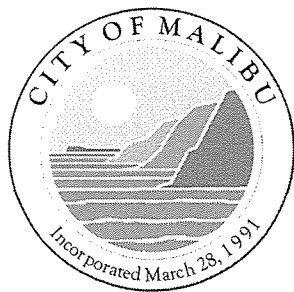

Subject: Update on Communications Infrastructure Improvements

---

**RECOMMENDED ACTION:** 1) Receive and file an update on communications infrastructure improvements; and 2) provide a recommendation to the City Council regarding installation of City radio transmitter equipment on Castro Peak.

**DISCUSSION:** The City has long experienced cell service and radio communication challenges, which become even more challenging if power is lost. During the Woolsey Fire, these challenges exacerbated the emergency response and the community's ability to get information. The City is now working to improve the situation through a variety of efforts.

The City does not currently employ a communications expert; therefore, a Request for Proposals will be issued in April to hire a radio communications consultant to provide subject matter expertise to the City. The consultant will be asked to evaluate existing communications capabilities for hand-held radio and public radio broadcasting. The consultant will be asked to develop a communications plan for improving all aspects of radio communication, including recommendations for strategically placed antennas, repeaters and other equipment, and coordination and/or partnerships with existing providers.

The City is also looking to increase hand-held radio coverage through additional City radio transmitter equipment. The City currently holds a license agreement with Point Dume, Ltd. for rental of property for City radio transmitter equipment, also known as a "repeater." However, the Point Dume site, at about a 200-foot elevation, is limited as a

citywide communication hub due to the topography of Malibu. Elevation above surrounding terrain is crucial for best signal transmission.

The Castro Peak repeater site sits at an elevation of 2,800 feet in the west end of the Santa Monica Mountains. Installing an additional radio repeater at Castro Peak will enhance the capabilities of the 35 hand-held radios the City currently owns.

The City is also scheduling opportunities for residents to become licensed amateur radio operators. The Community Services Department is planning a class and the City will also be partnering with the Sheriff's Department to offer an additional class.

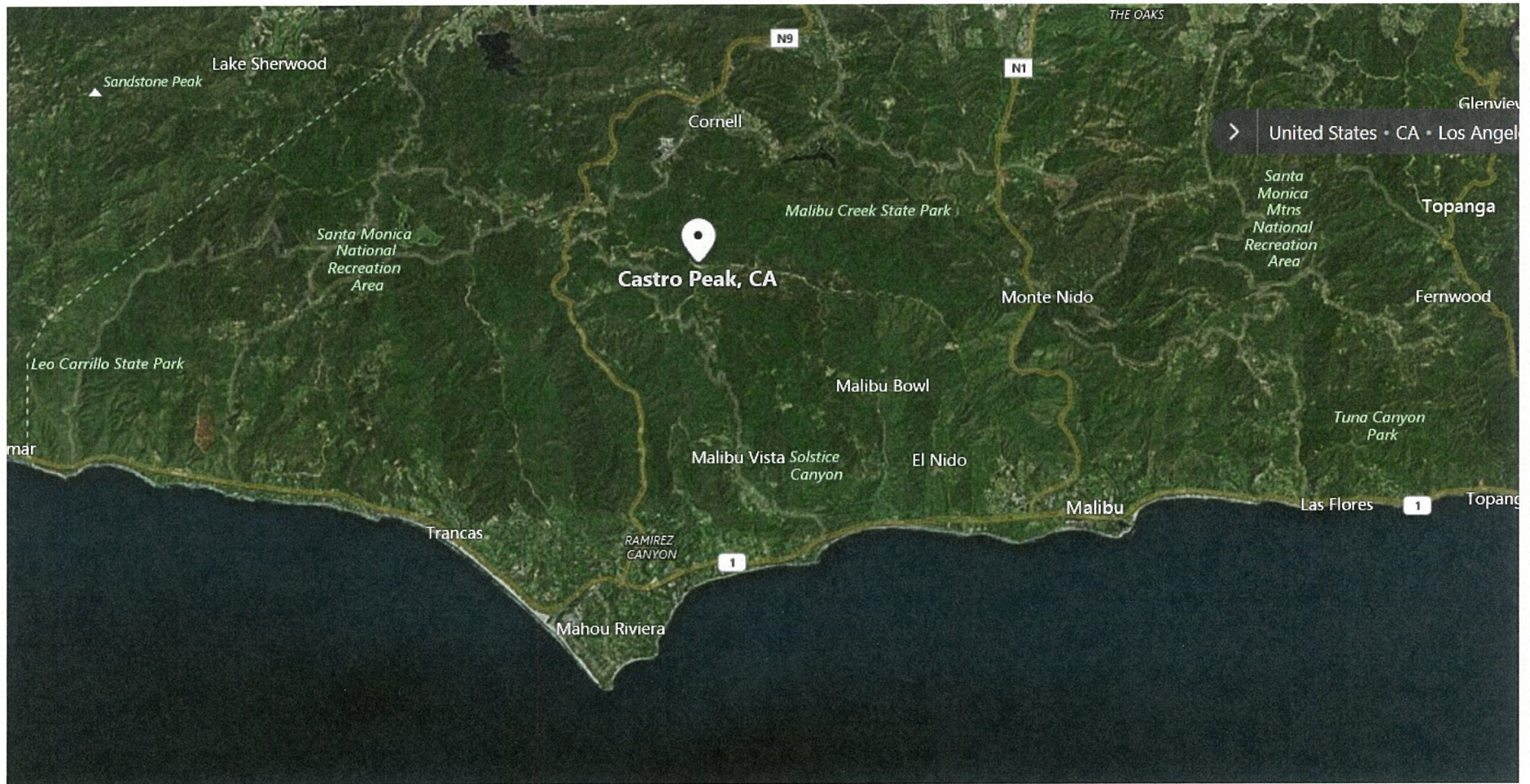
Malibu CERT Team Leader Richard Garvey will be in attendance to respond to technical questions from the Commission.

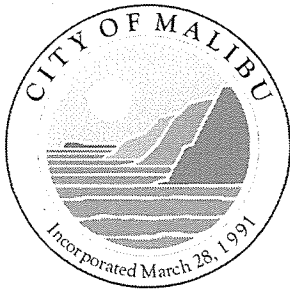
ATTACHMENTS: Map of Castro Peak Communications Site

**RECOMMENDED ACTION:** 1) Receive an overview of the commission assignment process and how items are added; and 2) Review Public Safety Commission assignments from FY 2018-2019, remove completed assignments, add new topics for consideration, and recommend that the City Council approve the revised task list for assignment in FY 2019-2020.

**DISCUSSION:** In recent meetings, the Commission has requested clarification of the process used for developing meeting agendas. Staff will provide an overview of the process by which the agendas are prepared based on the Commission's current assignments from the City Council, as well as how new tasks can be added to its list of assignments.

At its Regular meeting on June 11, 2018, the City Council approved FY 2018-2019 assignments for the Public Safety Commission (attached).

The City Council is scheduled to make assignments for FY 2019-2020 at its Regular meeting on June 10, 2019, and requests that each commission submit a list of suggested topics for assignment in the upcoming year.

The following assignments have been completed and, therefore, staff suggests they not be included in the request for reassignment in the upcoming year:

2. Provide input on the public safety element of the Malibu Strategic Plan on Homelessness (completed June 2018)
9. Conduct seasonal reviews of Point Dume and Busch Drive speed advisory sign data and provide feedback to staff (final report scheduled for May 2019)
11. Study areas in the City to be considered for requirement of safety enhancements that would prevent vehicle-pedestrian accidents (City Council adopted additional standards and amended Malibu Municipal Code Section 17.48.070 (Parking Lot Safety Standards) on October 8, 2018)

Staff suggests the following assignments from the current year be carried over as recommendations for ongoing assignment in FY 2019-2020:

- Review and provide input on the City's Emergency Preparedness Program and public safety activities
- Actively participate in the Strategic Plan on Homelessness Working Group (one Commissioner appointed)

- Meet with Southern California Edison regarding the potential to upgrade street lighting along PCH
- Meet regularly with a Caltrans representative regarding PCH traffic issues
- Review the proposed Summer Beach Team deployment schedule
- Study areas in the City to be considered for requirement of safety enhancements that would prevent vehicle-pedestrian accidents
- Make bimonthly oral reports to the City Council on Commission activity
- Submit a mid-year written report to the City Council on Commission activity
- Perform post-disaster assessment of City response, as necessary

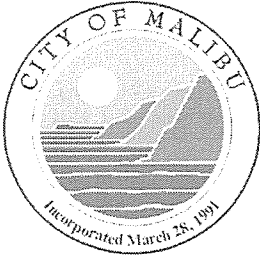
Staff also suggests the Commission request Council assignment of the following new tasks, including several to discuss and make recommendations related to areas of concern following the Woolsey Fire:

- Provide recommendations regarding a Repopulation Plan
- Review and provide feedback regarding CERT Team protocols, particularly regarding activation in a disaster
- Provide suggestions to the Sheriff's Department regarding Volunteers on Patrol (VOP) responsibilities during disasters
- Schedule a joint meeting with the Public Works Commission for consideration of items under the purview of both commissions
- Schedule a joint meeting with the City Council Public Safety Subcommittee

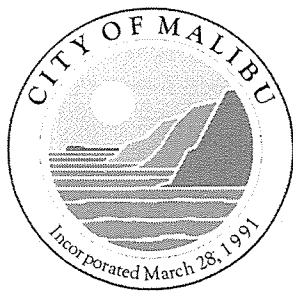

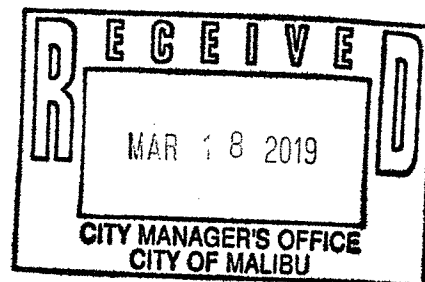



**INTERVENTIONS**

No interventions were held this month.

**COMMUNITY / CRIMINAL ISSUES**

1. We conducted a monthly parental resource class at Lost Hills Sheriff's Station. This program was developed by our unit and is designed to educate parents about: 1) The current trends in juvenile behavior and delinquency, 2) Alcohol/narcotic awareness and recognition, 3) School policy and campus issues, 4) Gang awareness and negative peer relations, 5) Parental rights and responsibilities and, 6) Parental responses to incorrigible and/or delinquent behavior. We also address the specific concerns relating to the minor's behavior. We educate the minor and their parents of possible criminal behavior and the legal consequences. We offer suggestions and make recommendations to improve the minor's quality of life.
2. Spoke with numerous citizens and parents who called to question various juvenile concerns and issues in the community. We also provide the parents with various juvenile resource programs within our community.
3. We met with the Sylmar Juvenile Court District Attorney regarding the investigation and filing of criminal charges against juvenile offenders.
4. Met with Acting Captain Salvador Becerra throughout the month in order to keep him up to date regarding our unit's investigations and current juvenile issues within our city.
5. Entered juveniles into the Juvenile Automated Index system for various violations.
6. Made court appearances to testify as witnesses on the part of the People of the State of California and attended court proceedings in cases generated from the City of Malibu. We also investigated, prepared, and filed cases with the District Attorney's office. We additionally assisted other investigators in the preparation of cases for court.
7. We met with station narcotic detectives on a regular basis to exchange information regarding juvenile and drug related issues. We have worked with the narcotic detectives on several narcotic cases directly and indirectly involving juveniles.

8. Handled the processing and follow-up of various juvenile referrals brought to the attention of this unit (i.e., Juvenile Information Forms, Field Interview Cards, Juvenile Automated Index, and citations for various juvenile contacts with uniform personnel).
9. Conducted our normal checks of juvenile problem areas in the city during weekend evenings and responded to juvenile related calls for service.
10. Updated the Gang Book and briefed the captain on criminal activity trends
11. Registered 4 sexual predators and updated information in database.
12. Attend Malibu High meeting.
13. Attended tobacco training with Ontario Police Department.
14. Assist patrol re: warrant checks.
15. Assist Detective Bureau re: inspection.
16. Assist field unit re: 14 year old female sexual assault victim.
17. Prepared school safety plans for patrol personnel.
18. Participated in the SST program.
19. Prepared tobacco undercover sting operations plan, and conducted Tobacco undercover operation for Westlake Village, Agoura Hills, and Calabasas.
20. Attended Teen Court prep meeting.
21. Filed court petition at Sylmar Juvenile Court.
22. Participate in Reality Party Event at Agoura Hills Recreation Center.
23. Attend Community 360 meeting at district.
