

NOTIFICATION

Sub : Cancellation of appointment letter in respect of 09 candidates who have been offered appointment to the post of Jr. Scientific Assistant in Gr. II and issue of fresh appointment list from the merit panel who have been considered for appointment against such 09 posts.

With reference to our notification of vacancies in Employment News dt. 1st March 2014 (1st to 7th March 2014 edition) and performance of candidates in Written Test on 26th April 2015 followed by interview conducted on 27th April to 30th April 2015 and 23rd June 2015 (for Physically Handicapped persons), total of 42 candidates were offered appointment. Nine (09) candidates out of 42 who have been earlier issued appointment have either not joined and/or expressed their inability in writing to join to the selected post of Jr. Scientific Assistant Gr. II resulting thereby work of the company is suffering badly.
