TERMS AND CONDITIONS

1. Snehbandhan is open for all and admission shall be given to male having age of 55 years and above and female of having age of 50 years and above. In case of husband and wife, age of the husband will be considered for admission.
2. Right to admission in the Senior Citizen Home will be with the Management of Trust.
3. At the time of submission of admission application, blood group certified through medical certificate and 2 colored passport photograph. The applicant will be required to submit the details of 2 legal heirs (name, address contact numbers). After the demise of the member, 1st legal heir mentioned in the application form will be only considered as only legal heir for all purpose. 2nd legal heir mentioned in the application form will be only considered as only legal heir after the demise of 1st legal heir. To admit applicants suffering from contagious diseases will be at the discretion of the Management Trustee.
4. If the admission is secured by giving false information the members will have to leave the home in next 24 hours.
5. Drinking, smoking, chewing pan, tobacco, gutka, non vegetarian foods is strictly prohibited. The members should ensure peace, harmony and cordial behavior with other fellow members.
6. The Management Trustee will have absolute right to evict any members not observing the rules and regulations and the trustee will not be under obligation to give reasons for their removal.
7. The member admitted should not bring any valuable in the premises and If he does do he will be solely responsible for any loss there of. Members are supposed to bring only essential items.
8. All cost of medical treatment and medicines will be borne by the members. In case of severe illness, person is admitted in a hospital at personal expense. On emergency Management will make arrangement to local hospital for treatment, however all the cost will be borne by the members and their relative and legal heirs.
9. Each room will be shared by 2 male or 2 female members with interest free security deposit of Rs. 30000/- each and monthly maintenance cost food, stay and other facilities for Rs, 5000/- per month payable on or before 10th of the month. If person desires to have single room he/she will be required to pay interest free security deposit of Rs. 60000/- and monthly maintenance of Rs. 10000/- per month. Husband and wife members will be permitted to stay in one room. The Trust will increase or reduce the monthly charges in future if required based on cost of living index.

10. If the member desire to stay in home after some time, the members is required to intimate in writing to the trust, however member will be required to pay the monthly charges for all intervening months.
11. The Management trustee reserves the right to increase the maintenance charge and the security deposit if required .
12. Advance intimation be given if family members and relative or their friends desire to meet the members to enable the management to make necessary arrangement for the food and stay and amount in advance will be required to be required to be deposited in the Trust Office.
13. On a death of members, Trust will inform their relative / legal heir immediately. If they fail to do come in next 8 hours, trust will cremate the body.
14. If the members leave the home within 3 months, 3 months monthly charges will be deducted from the interest free security deposit.
15. If the members intends to leave home temporary, minimum 30 days notice in writing is required to be given to the trust and If the members intends to leave home permanently within 10 years, Rs. 2000/- for each year will be deducted from the interest free security deposit and the balance will be paid to the member. (More than 3 months will be considered as 1 year for the purpose of deduction). In case of death of members the interest free security deposit will be paid to the 1st legal heir mentioned in the admission form.
16. It will be at the discretion of the Management Trustee whether to admit the same person who has already left earlier.
17. If any member is required to stay away from Trust home for longer period, the member will be required necessary details with regard to purpose and period of stay will be required to be intimated to the trust.
