

CROSSFIT EDWARDSVILLE CHILD CARE RULES AND WAIVER OF LIABILITY

1. We provide childcare during most afternoon and evening workouts. But you still must provide at least 24 hours notice so that we can make arrangements. Email cfechildcare@gmail.com to set your child(ren) up for free child care at CrossFit Edwardsville. Our child care manager will discuss the procedure for requesting childcare.
2. Please do not just show up with your child.
3. If for any reason you cannot make it to the workout and you have requested childcare please contact us immediately so that our childcare provider can be notified asap.
4. For safety reasons, no kids will be allowed on the gym floor or on any equipment. Children must remain in a supervised childcare room. Insurance regulations prohibit children being in the gym area or being unsupervised in the childcare room.
5. We have a variety of age appropriate activities and a TV and DVD player but feel free to bring other items (toys, snacks, videos etc) for your kids.
6. One of our values at CFE is personal responsibility. Have your child pick up after themselves and clean up any messes before leaving. If your children leave a mess and they do not pick it up, then you the parent must do so.
7. You will be held liable if your child causes any damage to any property at CrossFit Edwardsville.
8. If your child should become inconsolable during the class session, we will ask you to leave class and attend to your child.
9. You are responsible for feeding your child and taking them to use the restroom prior to start of class time and during class time if needed.
10. Your child will only be released to you and no one else unless you have notified CrossFit Edwardsville ahead of time as noted on the Family Registration Card.

Please note: With some exceptions, this is a free service that we offer to our members. All of our childcare providers are volunteers; so there may be some days especially during the summer months where we may not be able to schedule childcare. We apologize if the times that we have available do not accommodate your schedule; we are working towards having childcare available for more class times.
