## **2019 Strategic Topics:**

*Note: By making the most of the presence of the Heads of the world's five leading IP offices that have a great influence in the global IP arena and major Industry Group in the IP5 regions at a meeting, the strategic topic discussion can provide a forum to explore the future direction of the IP5 cooperation and ways the IP5 can contribute to improving the global patent system. It is the understanding that the IP5 Offices are not expecting that these conversations or topics will lead to projects or even tangible outputs. Instead, this is meant to be an open dialogue without a pre-conceived outcome, and discussion of these strategic topics is designed to be a "brainstorming" exercise for the future.*

**1:00 – 2:30   Impacts of and Preparation for NET/AI** (KIPO, IP5 Offices, IP5 Industry)

*Format: KIPO will introduce the topic for a roundtable discussion, followed by Industry IP5 reactions and commentary, with follow-up discussions and reactions from IP5 Offices.*

*Suggested discussion points are as follows but participants are not restricted by the points;*

### *1. Legal aspects of AI*

- a. What are the main challenges of patenting AI? Is the current patent system sufficiently equipped to protect AI inventions?*
- b. What aspects should be paid attention to by the IP5 Offices when they consider updating practices, guidance, regulations and relevant laws in light of developments in NET/AI?*

### *2. Utilization of NET/AI*

- a. How do technologies such as AI, Blockchain, Big Data and XML contribute to the quality of services and efficiency of operations?*
- b. With the number of filings going up globally, how can NET/AI mitigate the resource constraints at Offices? Will AI be able to help alleviate the burden?*

### *3. Interaction with users*

- a. How does industry prepare for the impact of NET/AI? and what actions does industry expect IP5 offices to take in responding to NET/AI?*
