4. Pay in your money using the paying in slip at the bottom of this form. Take the whole form to your local Barclays branch, deposit the money and return the top section to us.

For every £1 you give to Breast Cancer Now, we get an extra 25p from HM Revenue & Customs. So just tick the box below, it's that simple! To qualify for Gift Aid, you must be a UK taxpayer and what you pay in income tax or capital gains tax each tax year (6 April one year to 5 April the next) must be at least equal to the amount of tax that all the charities and Community Amateur Sports Clubs (CASCs) you donate to, will reclaim on your gifts for that tax year. I understand that if I pay less Income Tax and/or Capital Gains Tax than the amount of Gift Aid claimed on all of my donations in that tax year it is my responsibility to pay any difference. Other taxes such as VAT and council tax do not qualify. We can only claim Gift Aid if you give us your full home address, not an organisation's address.
