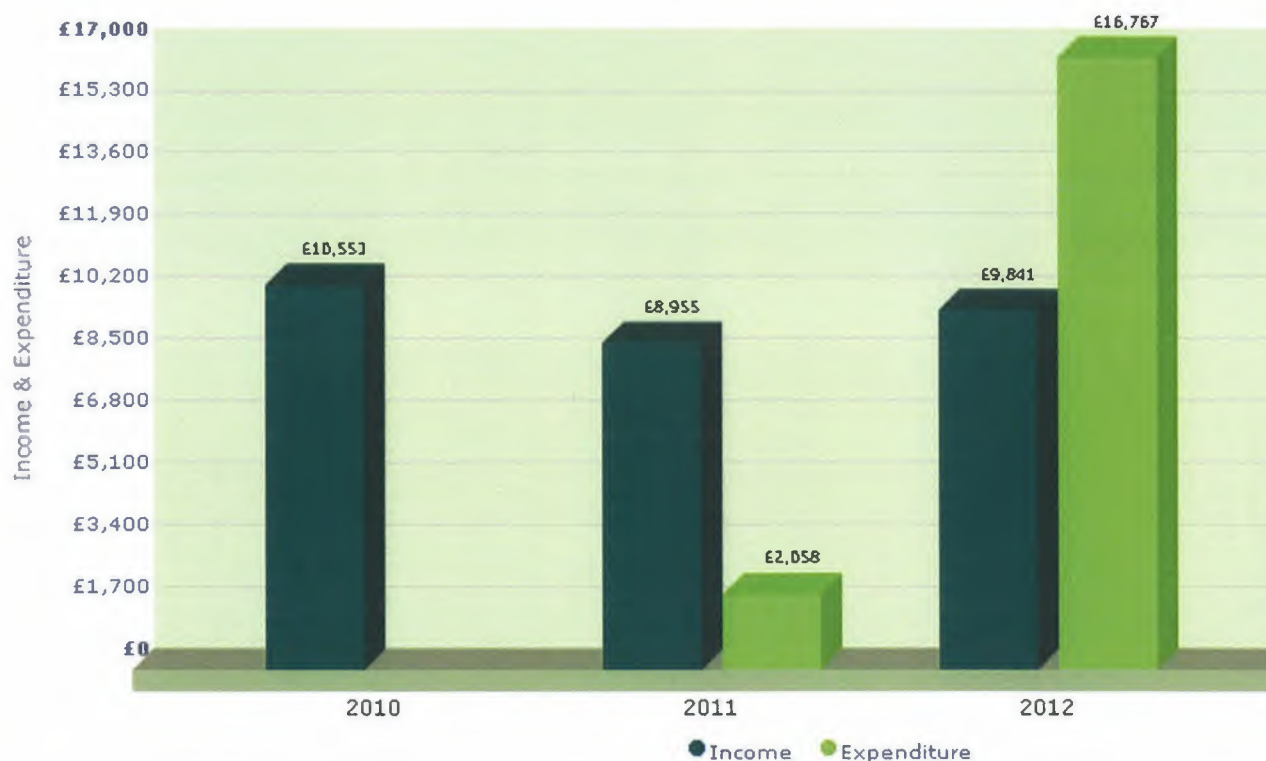
4.3 To advance community development, including urban or rural regeneration.
