

School EOP Checklist

The Emergency Operation Plan (EOP) should have the following sections:

- ☐ **Basic Plan** - The Basic Plan provides an overview of the school's approach to operation before, during, and after an incident. Addresses the overarching activities the school undertakes regardless of the threat or hazard
- ☐ **Functional Annex's** - Functional Annexes detail goals, objectives, and courses of action for functions that apply across threats and hazards.
- ☐ **Hazard Specific** - Threat/hazard/incident-specific annexes detail goals, objectives, and courses of action for a particular threat, hazard, or incident type.
- ☐ **Appendixes** – These appendixes could be any other plans that support managing and emergency in their school.

RED text = items required by RSA 189:64

BLUE text = items suggested to meet guidance outlined in the Comprehensive Preparedness Guide 101 (CPG101)

GREEN text = items that we suggest schools to include in their EOP

<u>Scan</u> <input type="checkbox"/> <i>Response action is activated when it is necessary for staff to look around their area for any item which doesn't belong there.
