Project comparisons are documents that help you compare the details of two or more project plans and identify their differences and outcomes.

## **What should a product comparison include?**

A product comparison must include the products' names, brands, features, descriptions, and prices.

## **How do you make a comparison chart?**

To make a comparison chart, you can use the spreadsheets of MS Excel or Google Sheets, or you can insert and create a table in MS Word, Apple Pages, or Google Docs.

## **What is the rule for comparison?**

The rules for comparison are there should be sufficiently accurate data and unbiased descriptions of the items in order to arrive at a credible conclusion.

The parts of a comparison document are the comparison table, the name of the conductor, the contact details of the conductor, and the business name and logo in the header.
