What do you check during due diligence?

When analysts conduct the due diligence process, they check the economic, financial, fiscal, and legal aspects of a company, organization or individual.

Why is it important to conduct due diligence?

It is important to conduct due diligence because it guides business firms, investors, and organizations to have a clear understanding of the nature of a business deal, the potential risks or problems involved, and to make sure whether the deal is suitable for them or not.

Can you negotiate after due diligence?

Who does due diligence when buying a business?
