National Paralegal Day History

The paralegal career path was made possible by the United States' first bar association, the State Bar of Texas, which established the Paralegal Division—originally known as the Legal Assistants Division—on October 23, 1981, and opened the door for many to pursue paralegal studies and jobs. On April 5, 1993, former Senate President Bob Bullock and former House Speaker Pete Laney signed the Texas Senate Concurrent Resolutions 69 declaring October 23 as Texas Legal Assistants Day. In 2005, proclamations were signed by the Texas House Representatives recognizing October 23 as Paralegal Day, then other states proclaimed their own celebration such as California Paralegal Day until it was celebrated nationwide as National Paralegal Day.

National Paralegal Day Purpose, Importance

It's no surprise that not everyone is aware of National Paralegal Day because it's not grand like Thanksgiving Day or the [4th of July](#), but it's a highly significant event for legal service professionals.

What's on National Paralegal Day?

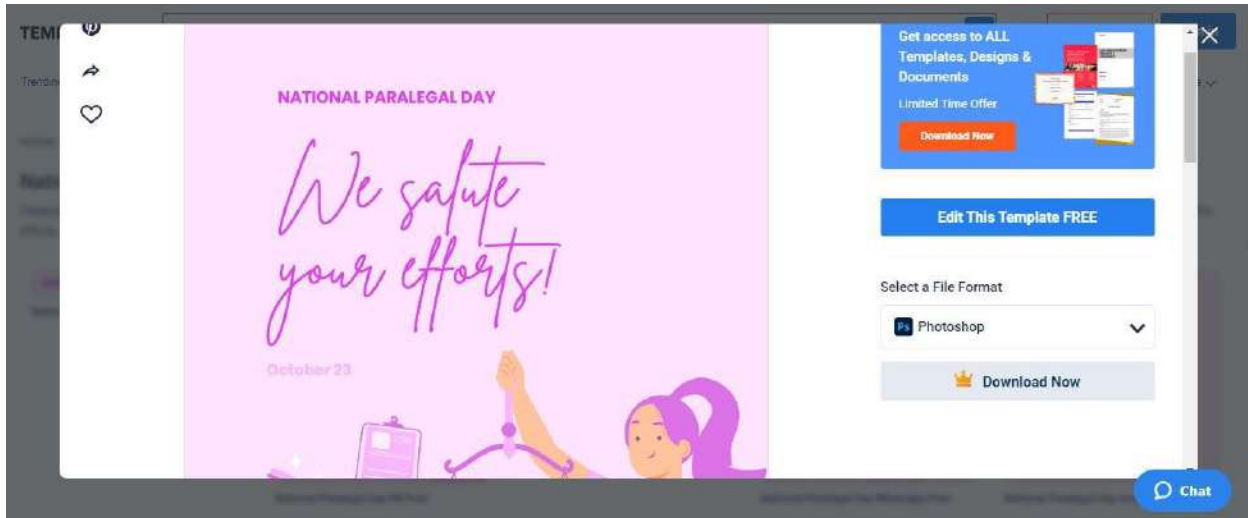

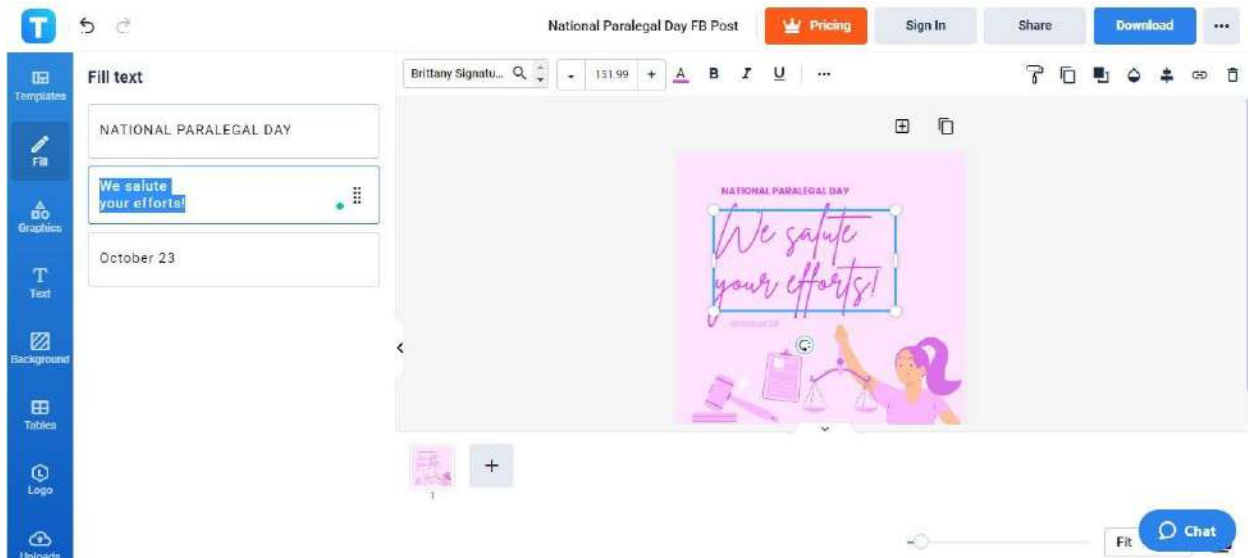

1. Take a [National Paralegal Day FB Post](#) as your template.



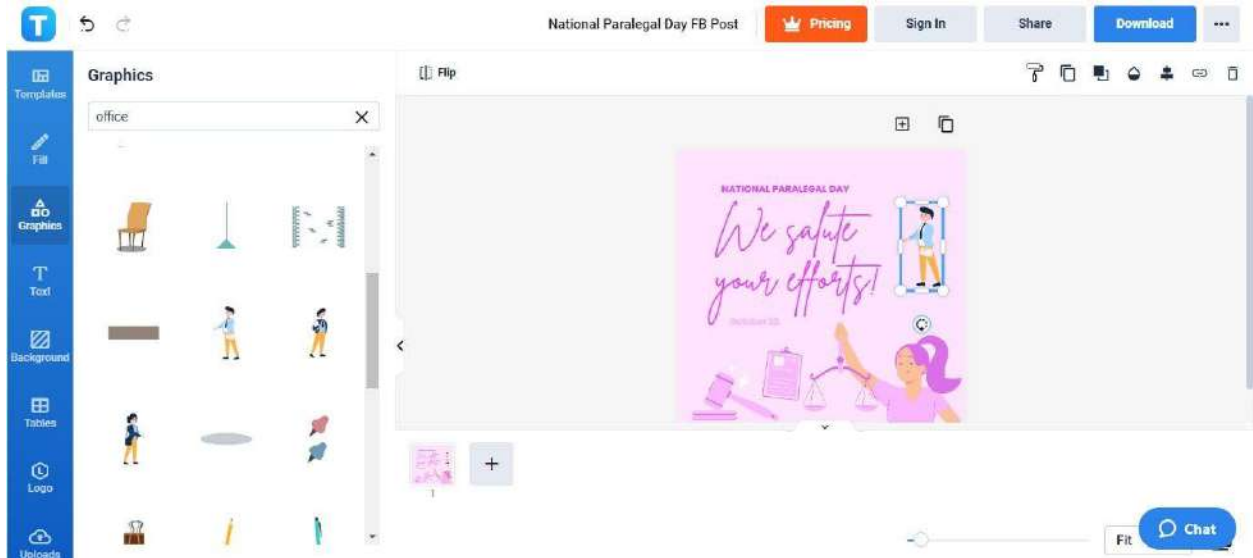

2. Write your National Paralegal Day message in the template.



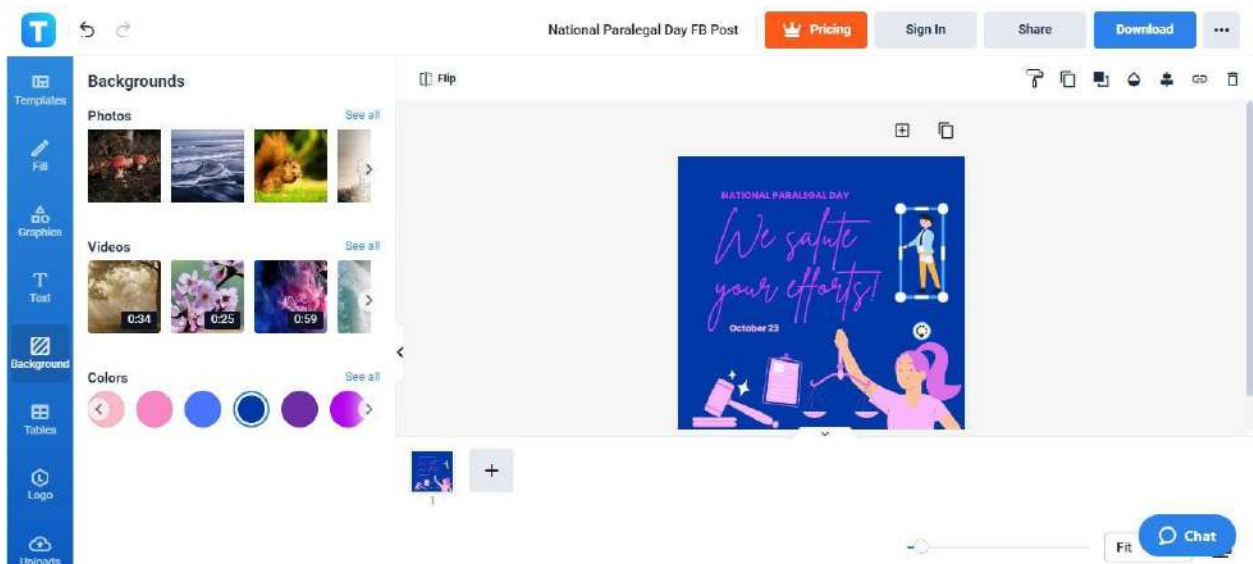

3. Add eye-catching graphics.



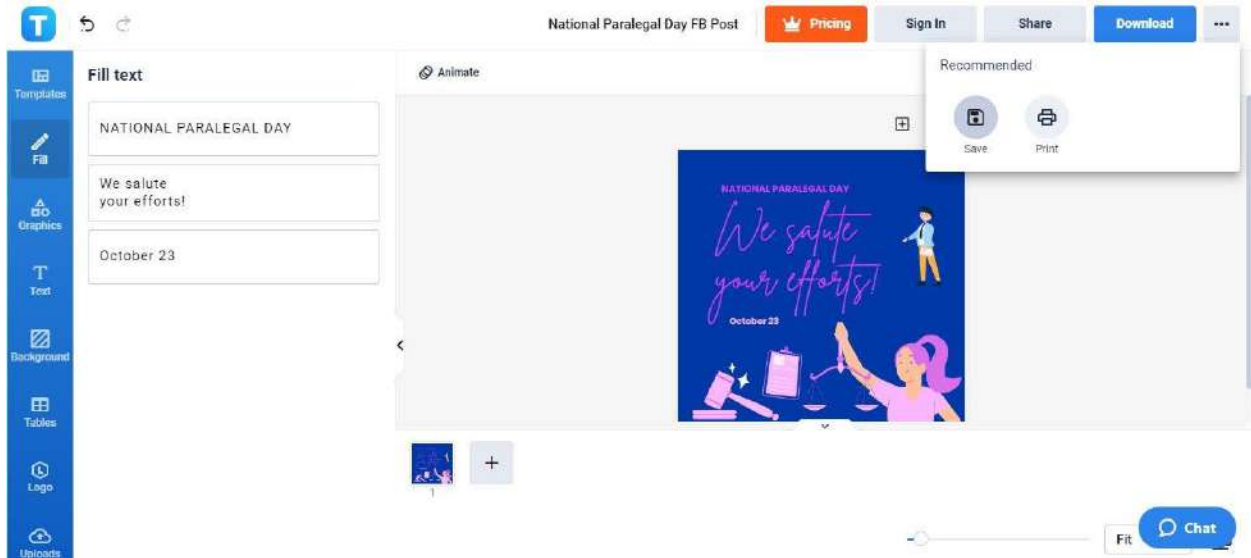

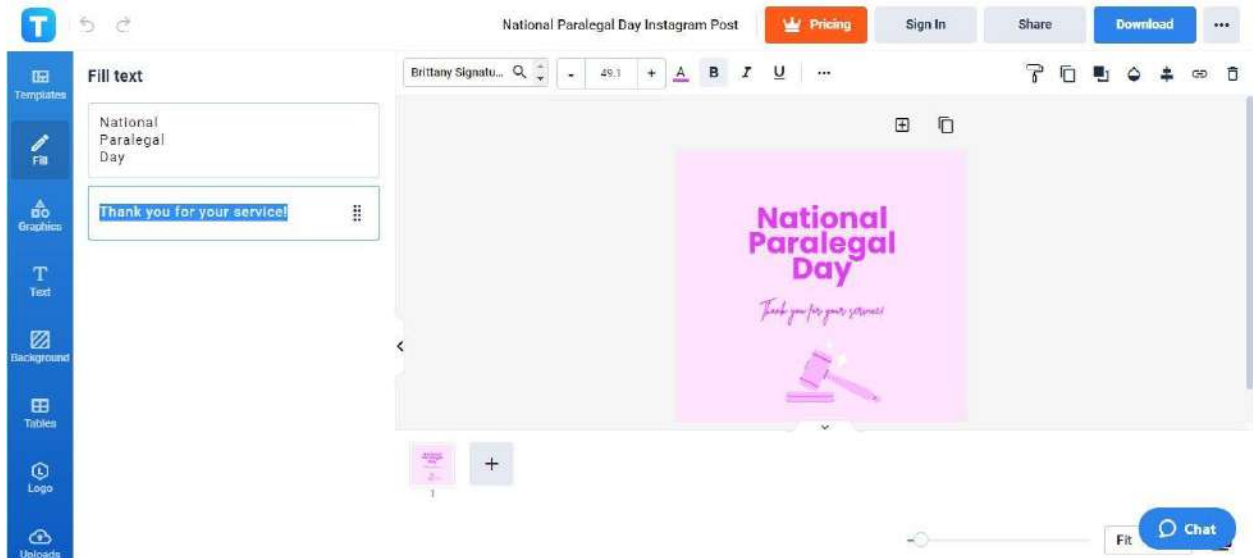

1. Choose an editable [National Paralegal Day Instagram Post Template](#).



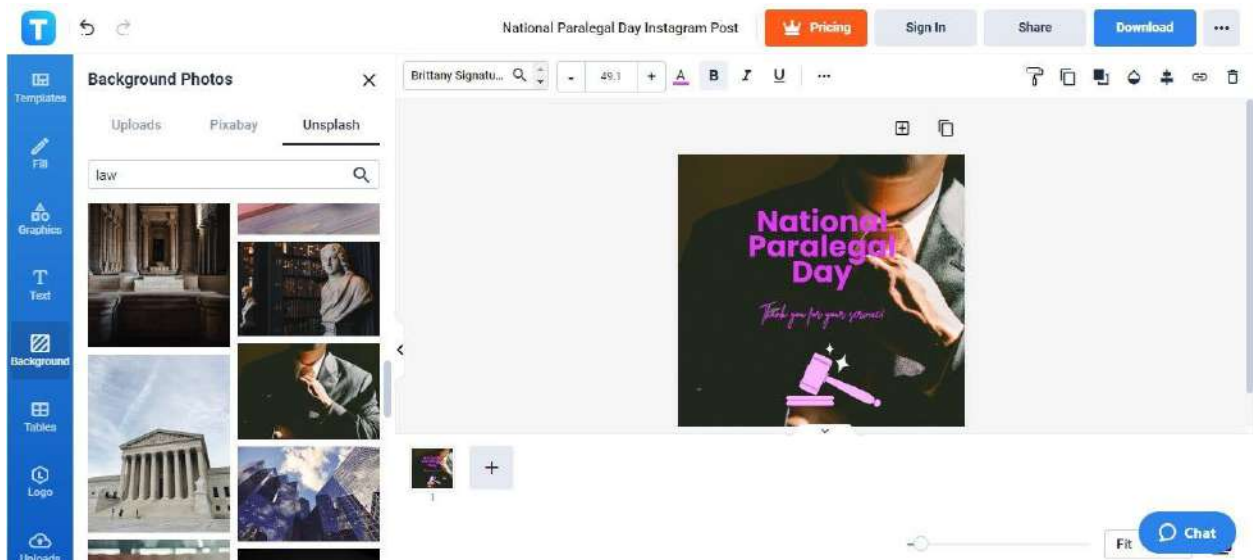
Take the National Paralegal Day Instagram Post Template and customize it in the Editor tool. To get started with customizing, simply select the button saying “Edit This Template FREE.”

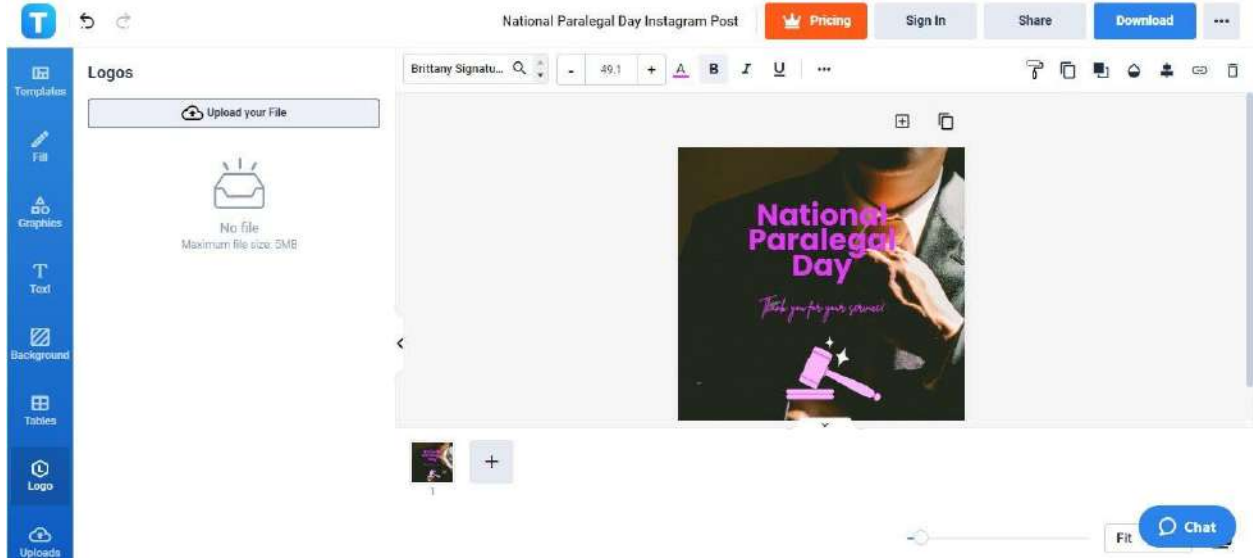
3. Use a high-quality photo as the background.

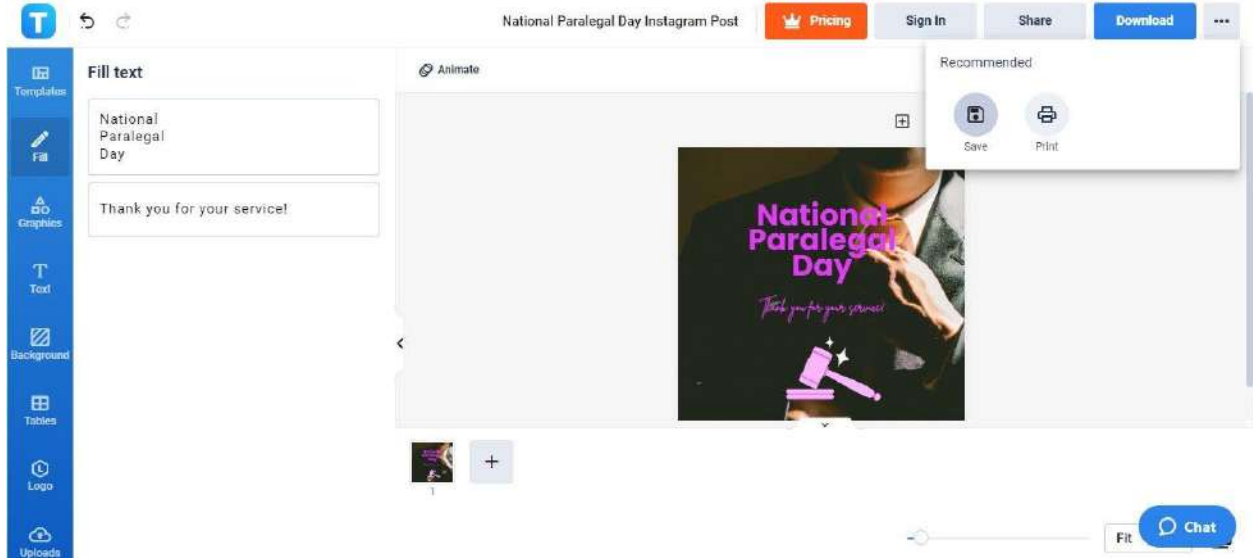
of law offices and professionals wearing business suits would be appropriate. Just click your chosen image to set it as the background.

4. Include the logo of your law firm.



If you work for a law firm, you should consider including its logo in the template. It's a way to let the paralegals out there on Instagram know that your firm supports them. To add the logo, go to the Logo tab of the Editor tool, click the "Upload Your File" button, and grab an image file of the logo from your file folders. Drag and drop it to the template once uploaded. The best spot to place the logo would be in the upper left or upper right corner.

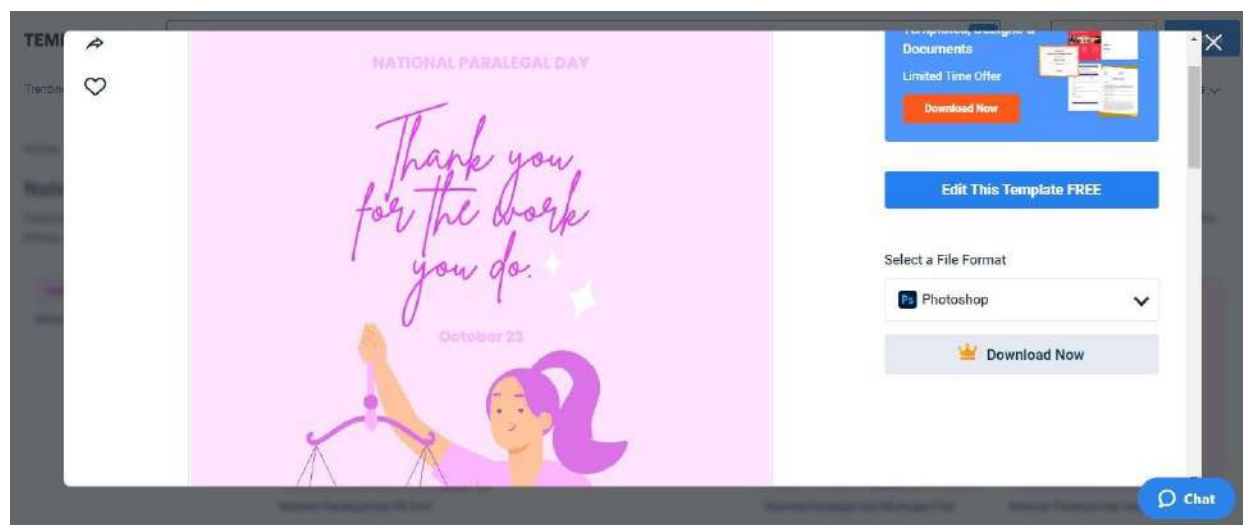
5. Save the edited template.

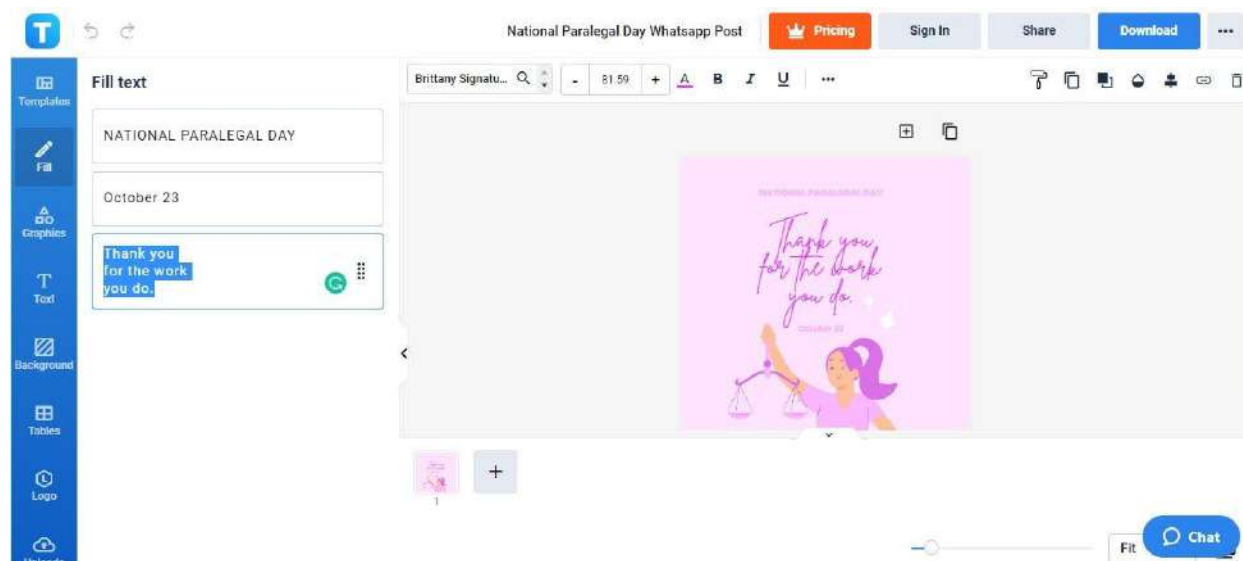

1. Open a customizable [National Paralegal Day Whatsapp Post Template](#).



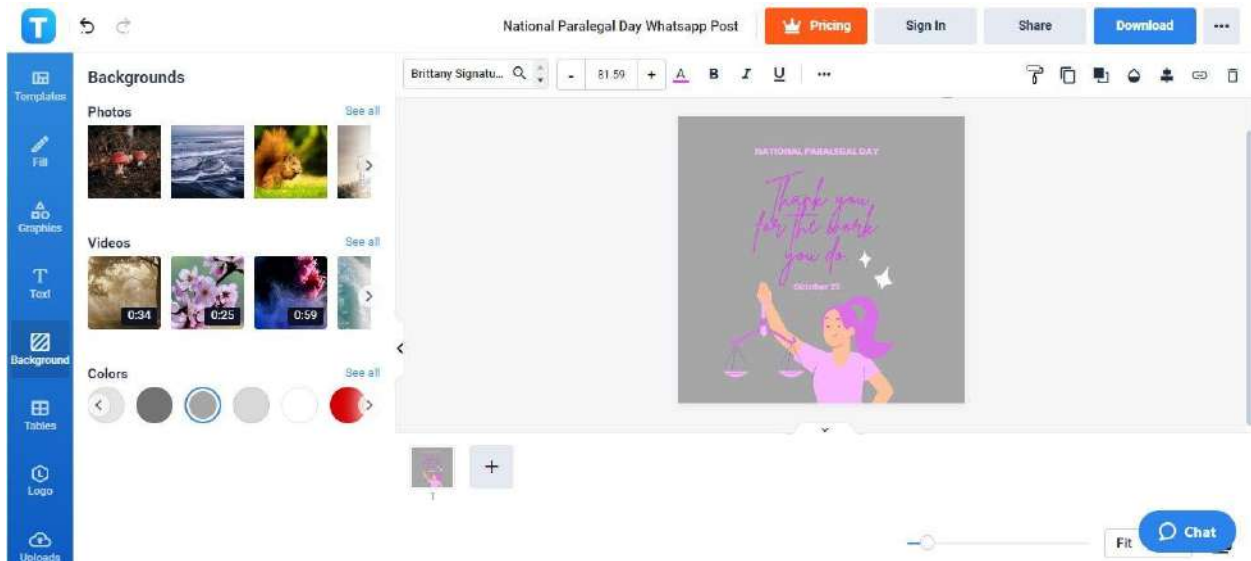

2. Type in your National Paralegal Day message, quote, or slogan.



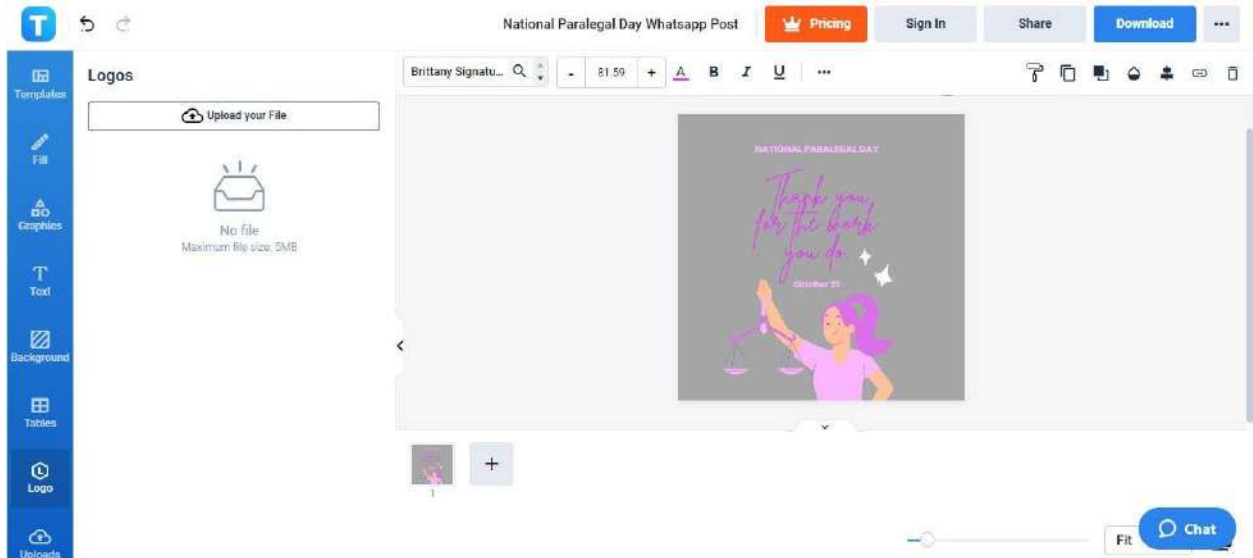

3. Personalize the background design.



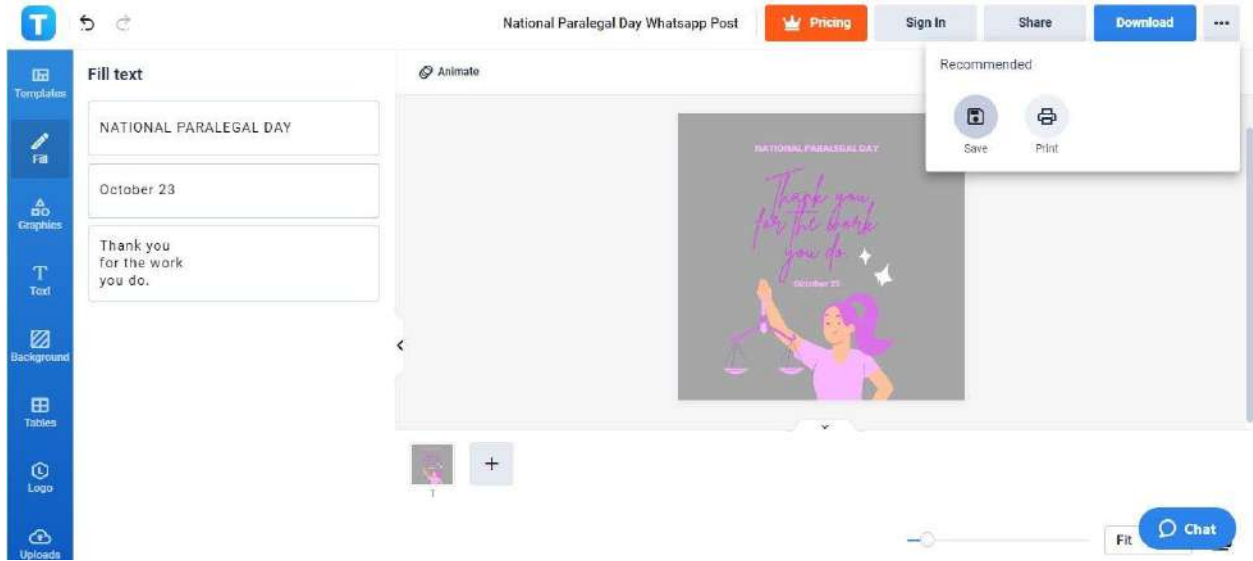
